Project Team Updates

- Project Manager updates I have provided include construction progress, but successful projects require different elements of the project team like administration, legal and finance.
- Contracts, Project Documentation, etc
 - The Board of Education voted in December to request that the county manage the grant funded BHS CTE Wing Project and Board of Commissioners confirmed agreement at their meeting on January 12 authorizing the manager to facilitate contract amendment negotiations. That work has begun. Once the contract amendment is confirmed, the programming study used in the grant application will be refined along with the project budget.
 - Project closeout documentation will be prepared and turned over to school maintenance and finance staff once all work is completed and invoices processed. This includes any warranty information and other information that will be important for future management of these facilities.
 - Any questions on interlocal agreement, contracts, grant administration or project documentation can be directed to administrative leadership.
- Financial Reporting and Budget Status
 - County finance is reporting the financial progress and budget status regularly on all capital projects including encumbrances to school finance and administration. The second FY 26 quarter report will be presented Monday, January 26 showing work invoiced and paid through December 31 with a copy of the full report on the county finance website. Any questions on financial reports and budget will be addressed by county finance.
