Subject: 2024-25 Budget Amendment #9

Attached is Budget Amendment #9 for the 2024-25 Budget for Transylvania County Schools.

After approval of the amendment, the allocations for all funds will be as follows:

Since Budget Amendment #8 was approved at the June Board meeting, one additional allocation of 76 cents was received in PRC 230-School Nutrition Helene Funds to sure up expenditures to allotment. Several adjustments were made between purpose/function 5XXX, 6XXX and 7XXX for the final amendment.

In the Local Current Expense Fund, several adjustments were made between purpose/functions 5XXX, 6XXX and 8XXX. Also, \$550,000 was appropriated from fund balance to cover arrears period after June 30<sup>th</sup>. The remaining amount will revert back to fund balance once all transactions are made for 2024-25.

For the Federal Programs Fund, an additional allocation of \$32 was received in PRC 111 and \$27,192 was received in PRC 060-IDEA Special Needs. Adjustments were made between purpose/function 5XXX and 8XXX.

No changes were made to the Capital Outlay Fund.

In the Child Nutrition fund, an addition of \$240,000 was made to the budget to cover audit entries.

For the Other Specific Revenue Fund, \$2000 was budgeted in PRC 056- Transportation, \$110,298.47 was budgeted in PRC 805 for the SELF program and \$49,313 was budgeted to PRC 015-School Technology. Adjustments were made between purpose/function 5XXX and 6XXX.

I respectfully request approval and acceptance of this budget amendment. Thank you in advance for your consideration.
