Purpose of Title Allotments

Title I - Title I is designed to provide all children significant opportunity to receive a fair, equitable, and high-quality education, and to close educational achievement gaps (**Reading & Math**).

\$1,032,908.60

Used for: teachers, TAs, supplies and materials, 1% required for Parent Involvement-\$10,329.00

Title II- Preparing, Training, and Recruiting High Quality Teachers and Principals. To increase student academic achievement through strategies such as improving teacher and principal quality and increasing the number of highly qualified teachers in the classroom and highly qualified principals and assistant principals in schools; and hold local educational agencies and schools accountable for improvements in student academic achievement. \$159,000 (**High Quality instruction /People**)

Title III- to help ensure that children who are limited English proficient, meet the same challenging State academic content and student academic achievement standards as all children are expected to meet;) to develop high-quality language instruction. \$20,000.00 (**MLs 217**)

Used to pay for part of 1 ML Specialist that serves as a coach for all of the other teachers and ML Specialists.

Title IV- \$79,000.00

Well-rounded education- (assessments aligned to SCOS)- \$26,000.

Support safe and healthy students- (part of a counselor for DRS)- \$28,184.66

Effective use of technology (Google Read Write)- \$24,815.34

- **These federal funds mainly allow us to hire teachers to reduce class size, offer tutoring, materials, etc. to meet the needs of students.**
- **Pay for 15.5 teaching positions**
