D. Scope of Work

For purposes of communication and establishing expectations, the following summarizes standard scopes of work to be completed for individual pieces of equipment at the community locations. Some inspection line items may be excluded based on the type and size of the equipment. Assumptions were made during the pricing phase, which will be validated during the initial inspection.

- Supply and install a new NVR Video Recorder at each of the 2-school campuses.
- Deploy an Enterprise Camera VMS system with <u>unlimited client licenses and no recurring</u> software costs.
- Supply and install network switches with sufficient capacity to handle the required POE-powered cameras.
- Provide and install Cat-6 cabling to all new cameras following industry standards.
- Install two conduit sleeves in Rosman HS media center.
- Provide and install fire-rated sleeves and fire stop where required.
- Use existing cable hooks with additional supports as needed.
- Remove the old camera equipment and turn it over to the owner. Removal of wiring is excluded if it risks damaging active wiring.
- Conduct 2–4-hour training sessions on the new equipment.
- Providing Client software for owner install. Clients must meet the VMS requirements.
- Obtain Trade Permits from the county.

E. Exclusions

The price of this agreement has been determined based on routine maintenance and repair of equipment problems which are intrinsic to the equipment and not caused by outside sources. Accordingly, we must exclude the following from coverage:

- Client viewing computers and their associated software installation and cabling/networking needs.
- Any 120 Volt power needs.
- Repairs to owner provided Fiber Optic cable.
- UPS Battery Backups.
- Painting, patching, and ceiling tile replacements.
- Liquidated damages.

Form E-589CI, Affidavit of Capital Improvement, is generally required to substantiate that a contract, or a portion of work to be performed to fulfill a contract, is to be taxed for sales and use tax purposes as a real property contract with respect to a capital improvement to real property.

- This affidavit may not be used to purchase building materials, other tangible personal property, or digital property to fulfill a real property contract exempt from sales and use tax.
- A person who willfully attempts, or a person who aids or abets a person to attempt in any manner, to evade or defeat a tax imposed by the Sales and Use Tax Laws, or the payment thereof, shall be guilty of a Class H felony. If there is a deficiency or delinquency in payment of any tax due to fraud with intent to evade the tax, there shall be assessed a penalty equal to 50% of the total deficiency.
