#### MLK Day, National Day of Service - January 16, 2023

Observed each year on the third Monday in January, Martin Luther King Jr. Day celebrates the lasting legacy of the famed civil rights leader to our country and its citizens. Martin Luther King Day is the only federal holiday designated as a National Day of Service to encourage all Americans to volunteer. Our thanks to the students, staff, and neighbors who worked on January 16<sup>th</sup> to help improve their communities and commemorate Dr. King's legacy of service.

Chairman McCoy shared the next item:

#### NCSBA Academy for School Boardsmanship

Each year, board members are recognized for their training achievements through the North Carolina School Boards Association *Academy of School Boardsmanship*.

Certificates are given when a board member has earned a minimum of 30 hours of training during the previous academic year. The level of recognition is based on the total cumulative hours of training earned. Congratulations to Ron Kiviniemi for earning a Certificate of Advanced Achievement during the 2021-2022 academy year. This level of recognition means that Mr. Kiviniemi has achieved 201-300 total cumulative hours of training.

#### Miss Bengal Pageant

Congratulations to Clara Kochan for being named "Miss Bengal 2023" at the Rosman High School Miss Bengal Pageant held on Saturday, January 14, in the RHS auditorium. Clara is a junior and an exchange student from Germany.

Dr. McDaris recognized the student artwork from Rosman Elementary School that was on display in the board room.

# 4. Former Students in the Military

The board recognized the list of former students from Brevard High School, Rosman High School, and Davidson River School who are currently serving or have previously served in the U.S. Military. There were no new names on the list.

# 5. Consent Agenda

ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. JACKSON, the minutes of the August 2, 2022 meeting; the August 22, 2022 meeting; the August 22, 2022 closed session; the September 19, 2022 meeting; the September 19, 2022 closed session; the personnel report for January 17, 2023 (attached); and five applications for local training credit for the "School Board Member Rights and Responsibilities" session on December 19 were approved by 4:1 majority vote (FOR: Dalton, Jackson, Kiviniemi, McCoy; AGAINST: Wiener).

#### 6. School Calendar 2023-2024

Dr. Brian Weaver presented the draft school calendar for the 2023-2024 school year as recommended by the calendar committee. The draft contains many similarities to the current school calendar in that there was little flexibility for change due to North Carolina's calendar law, and because our system did not meet the threshold for a weather waiver which would have allowed an earlier start date. The committee therefore based the start date of Monday, August 28 and end date of Friday, June 7 on current calendar legislation. Spring break would be the last week of March. Dr. Weaver pointed out one notable change--the committee decided to move away from remote learning days and return to early release days for better instructional delivery and to allow students to have lunch at schools. Mr. Jackson asked why there were not 185 instructional days in the calendar. Dr. Weaver explained that state calendar law requires either 185 days or 1,025 instructional hours. We meet the hours requirement.

There was extensive discussion about the state calendar law as a barrier to completing first semester exams before Christmas. Board members expressed concerns that students taking first semester exams in January could experience learning loss over the break, plus have hardships from misaligned scheduling windows for dual enrollment and/or spring semester enrollment at local community colleges. Kimsey Jackson spoke about his experience with a quarter system at NC State in 1952. Mr. Wiener stated that he would like to see the calendar committee to prepare an alternate calendar that works best for the community.

The board discussed the potential consequences of adopting a calendar that violates state calendar law. A number of NC school systems have already done so. In Union County, some parents have filed a lawsuit against the board because the adopted calendar violates state law. Mr. Kiviniemi remarked that as long as Phil Berger is Senate Pro Tem, lobbying the legislature will do no good. Over the years, dozens of calendar bills have been proposed and none have ever made it out of the Rules Committee. Dr. McDaris noted that the state calendar law has never been about what is best for students, but what is best for the travel/tourism industry and summer camps.

Chairman McCoy asked the board attorney to weigh in. Mr. Campbell advised that the administration may not recommend a calendar to the board that violates state law. Other school boards have asked their administrations to bring back an alternate calendar for discussion. The Union County lawsuit is new and it is not known how that will play out. Board members can be held accountable for not following the duties of their office. This continues to be an evolving situation.

Mr. Kiviniemi stated that he is not ready to go against state law, but would be interested in seeing an alternate calendar as information. MR. KIVINIEMI MOVED to direct Dr. Brian Weaver to reconvene the calendar committee in order to prepare a second draft calendar that would allow first semester exams before Christmas and to present the alternate calendar for review at the work session on February 6. MR. WIENER SECONDED, and the motion passed unanimously. Dr. Weaver informed that board that in the interest of time and with the board's permission he would convene the committee via email as they had already discussed the possibility of an alternate draft during their previous meetings. There was a general consensus to approve the email meeting.

### 7. Budget Update

Finance Officer Gabi Juba presented an expenditure report and three budget amendments for fiscal year 2022-2023. ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. JACKSON, the budget amendments for the State Public School Fund, the Local Current Expense Fund, and the Federal Grants Fund were unanimously approved as presented (see attached). Reviewing the expenditure report, Mr. Wiener asked to what other governmental agencies the school system sends money. Mrs. Frost explained that NC school systems are required by law to send payments to charter schools that are attended by students who live within the local district, even if the charter school is located in another county. Charters are public schools and therefore governmental units.

#### 8. School Capital Bond Update

Dr. McDaris reported that he and the board attorney have been working with the county manager and the county attorney on forming an ad hoc advisory committee in an attempt to move the bond/capital projects forward. Talks have begun with some individuals and the county is working to identify some consultants. Work is progressing slowly.

Mr. Campbell reported that since Thanksgiving the county has been looking at some internal issues. The plan is to ask a retired county manager and a retired superintendent to serve on the committee. The bond deadline is November 2025. It can be extended until November 2028. That would make it 10 years since voters approved the bond in 2018. Our finance officer is working with the county finance officer to identify the capital dollars that will be available to the school system in the next 2-3 years. An update will be provided update at the February 6 work session. Mr. Kiviniemi stated that he would also like to know the total amount of county tax dollars that will have been collected by the

end of this fiscal year based on the tax increase that the county implemented and attributed to the bond.

Chairman McCoy reported that the board had originally planned to receive a report from the ad hoc committee in February; however, that deadline will not be met due to delays on the county's side. The ad hoc committee has not been fully formed. If the county decides it wants more review of the school system's needs, it will take even more time. Mr. Campbell noted that the board is not in control of all the pieces of this equation. He believes the superintendent and county manager are doing a good job of trying to move things along.

# 9. <u>Topics for Planning Work Session</u>

Dr. McDaris gave a reminder that the board will hold its annual planning work session on February 6, 2022 at the Morris Education Center beginning at 5:30 p.m. The following potential topics have been submitted so far: learning loss update, school safety and security, computer science graduation requirement, partnerships with BRCC and CTE offerings, school capital, alternative calendar for 2023-2024, and funding challenges for Exceptional Children's services.

#### 10. Superintendent's Update

As an item of interest, Dr. McDaris presented a comparison of the differences in the *Public School Laws of North Carolina* books from 1984 to 2021. The 2021 edition is several inches thicker. He then gave the following announcement:

"Anyone who knows me knows that I have five favorite things: my grandchildren, home projects, writing stories, visiting places featured in *Our State* magazine, and North Carolina barbecue joints. I mention this because there is not enough time to spend with my favorite things. This is my  $40^{th}$  year as an educator in North Carolina. I started school in 1967, so I guess in many ways I've been in school for 56 years now. And each year is unique. I still get excited for the first day of school in August. Elementary school, junior high, high school, college--I am blessed to be a graduate of this school system.

Last July, just after my mom passed away, I began to reflect on many things, including my career. I've had many colleagues and friends retire, especially during the last few years. As we grow older time seems to go by faster and faster. The job of a school administrator is rewarding but tough. It requires a lot of time, energy, critical thinking, and dedication. Many things happen every day. Some are good, and some are not so good. But the good always outweighs the challenges. I am blessed to be in my 14<sup>th</sup> year as superintendent of this excellent school system. We have wonderful students, teachers, and families.

Admittedly, I am tired. My current contract as superintendent runs through 2024. Many retirees have told me, "You will know when it is time." Last summer when reflecting on the years I also thought about the many things I've missed out on for my family due to the job. I knew it was time. Last August I decided this would be my final year. I began the year focused on getting another year started and well underway. I knew that January would be a good time to announce in order to give the school board a solid time frame for selecting someone new, so I began making plans to announce my retirement at this first meeting of the calendar year. It's been hard to keep it a secret. But here we are now at that meeting.

My wife retired last year, and I shared my plans with her and some of my closest friends and family early on. I have to say, I think they did a pretty good job of keeping it secret. But speculation always abounds. I appreciate their support. I shared the decision with Chairman McCoy in early October, as well as some other key folks. I've

had many wonderful experiences with leaders and educational organizations across North Carolina. Jobs may have a time limit. Friendships do not.

While none of us know what the future brings, my faith assures me the future will ultimately end well. I've tried to listen and to seek His guidance and direction for each day, including now. It is time. I have new opportunities to explore, and Lisa and I have new adventures to consider. I am lucky. I am married to my high school sweetheart, I have two great sons, two wonderful daughters-in-law who have become daughters, and three awesome grandchildren. I am looking forward to spending more time with my family.

I will be retiring at the end of this school year on June 30, 2023. Between now and then, my work and dedication remain focused on this great school system, its students, our staff, and our great community. We always have a lot to do and I look forward to a great spring."

Chairman McCoy commented that the board has always teased Dr. McDaris about having contingency plans A through G. She expressed confidence that he will be leaving our system in a good place with a great leadership team.

KIVINIEMI, the board voted unanimously to go into closed session pursuant to N.C.G.S. § 143-318(a)(1) and (3) to discuss confidential personnel matters pursuant to G.S. § 115C-319-321 and matters protected by attorney-client privilege. After a brief recess, the closed session convened at approximately 7:55 p.m. The following board members were present: Tawny McCoy, Chair; Kimsey Jackson, Vice Chair; Tanya Dalton; Ron Kiviniemi; and Chris Wiener. Board Attorney Chris Campbell was also present. At 8:57 p.m., BY MOTION MADE BY MR. KIVINIEMI AND SECONDED BY MR. WIENER, the board returned to open session.

There was no further business, and ON A MOTION BY MR. KIVINIEMI, SECONDED BY MRS. MCCOY, the meeting was adjourned at approximately 9:00 p.m.
