The Transylvania County Board of Education met in regular session at 6:30 p.m. on November 16, 2020 at the Morris Education Center. In accordance with the remote meetings statute from the General Assembly and the Governor's guidelines, the meeting was conducted remotely and public access was not permitted. The public was invited to view the meeting livestream at https://voutube.com/tcsnc. Persons wishing to make public comment were invited to email their comments by 1:00 p.m. in order to have them read aloud as appropriate within board guidelines. Marty Griffin led a moment of silence and Alice Wellborn led the Pledge of Allegiance. Chairman McCoy welcomed everyone and called the meeting to order. 1. Approval of Agenda

ON A MOTION BY MR. GRIFFIN, SECONDED BY MR. KIVINIEMI, the meeting agenda for November 16, 2020 was unanimously approved as presented.

2. Special Recognition

Dr. McDaris recognized Alice Wellborn, whose tenure on the board of education will end this month. Mrs. Wellborn retired as school psychologist and exceptional children's specialist in 2013. She was elected to the board in 2016. During her four years on the board, and throughout her career with the school system before that, she devoted countless hours to improving services and programs for the students and staff of Transylvania County Schools. The board presented an engraved plaque to Mrs. Wellborn in appreciation for her outstanding contributions and leadership. Board members and others offered personal tributes:

4. Good News Report

Dr. McDaris recognized the student artwork from T. C. Henderson that was on display in the board room and thanked Attorney Caudle and Officer Owen for attending the meeting. He reported the following items:

MAKING ENDS MEET

Transylvania County Schools Child Nutrition Director Carolyn Barton has requested almost \$18,000 in free food from the USDA and has signed up for an additional \$39,000 for a total of \$57,000 in USDA commodities. This will be a tremendous help in making ends meet this year.

TCSEF CREATIVE CLASSROOM GRANT APPLICATIONS FOR 2021-2022

Teachers, administrators, and even students have incredible ideas that deserve to be implemented in classrooms, but finding funding for these ideas can be challenging. Every year, the Transylvania County Schools Educational Foundation (TCSEF) distributes Creative Classroom grants to educators across Transylvania County to support innovative and unique projects designed to enrich classrooms. Due to times and circumstances, the TCSEF has limited funds available; however, they look forward to seeing how they can support the creativity of TCS students, teachers, and staff this year. Applications for the 2021-2022 Creative Classroom grants are available now at https://tcsef.org/creative-classroom-grants/. Applications are due by midnight on Friday, December 4, 2020. Grants will be awarded in early 2021. All teachers and staff employed with Transylvania County Schools are eligible to apply. Winners will have 18 months to use the awarded funds.

NCSBA EXECUTIVE DIRECTOR

Leanne Winner has been named as the new Executive Director of the North Carolina School Boards Association, effective January 5, 2021. Ms. Winner will be organization's fourth Executive Director and the first woman to hold the position. She succeeds Dr. Ed Dunlap, who is retiring after 41 years of service to NCSBA, including 27 years as the executive director. Ms. Winner has worked for NCSBA as its Director of Governmental Relations since 1998. Throughout her tenure, she has advocated effectively on behalf of school boards at the General Assembly and with various state government agencies. Ms. Winner was selected from a pool of over 200 candidates nationwide. We congratulate Ms. Winner and look forward to working with her in her new role.

7. CTE Honors Internship

Director Missy Ellenberger presented a proposal for students working in an approved CTE internship capacity to earn honors credit. She stated that offering an honors option would give students the opportunity to gain a deeper understanding of their selected career/industry, an increased academic challenge, opportunity to earn quality points and higher GPA; and a more competitive resume and/or college application. Mrs. Domokur reported that a CTE student had interned in her family's business recently and it was a very good experience. Mr. Griffin asked how many students would be involved. Mrs. Ellenberger reported that 12 students completed internships last year, and 3-4 of those would have qualified for honors credit if available. The board thanked Mrs. Ellenberger for her presentation and expressed support for the proposal. Approval will be requested at the next regular meeting.

8. <u>Bond Projects Update</u>

Norris Barger presented the latest budget and expenditure report and gave a status update. After getting valuable input from various departments, Mr. Barger anticipates much dialogue with the architects and CMAR over the next few months. Mr. Kiviniemi asked when new cost estimates would be ready. Mr. Barger hopes they will be ready for the next board meeting. Mr. Griffin reported that people are asking if the bonds have been issued yet and if we are still on track to break ground in May. Mr. Barger reported that yes, we are still on schedule, and no, the county has not issued the bonds. How and when the bonds are issued will be up to the board of commissioners. Mrs. Domokur asked if there have been any COVID-related delays. Mr. Barger reported that Vannoy has had issues with some finishing materials on other jobs, but nothing that has impacted our projects at this point. Chairman McCoy shared compliments she has received regarding Mr. Barger's stewardship of the projects. Mr. Barger commended the school staffs for their involvement during the planning process. He added that the architects said they have never received so much input from staff on any of their previous school projects.

9. <u>DPI Facilities Needs Survey</u>

Every five years, local boards of education are required by G.S.115C-521(a) to submit their Facility Needs Assessment (long-range plans) to the State Board of Education. The assessment provides an estimate of current and future student capacity and a cost estimate of what it would take to meet that capacity and bring facilities up to DPI standards. Norris Barger presented the 2020-2021 DPI Facility Needs Survey for Transylvania County Schools. He explained there are differences between this plan and the TCS master facilities plan due to reporting methodology and format. The state indicated that projects already "in the works" with funds available should not be included in cost estimates. Therefore, Brevard High, Rosman High, and Rosman Middle are not included.

Board members had questions about some numbers. Mr. Barger explained that the 93% figure reported as the percentage of students with reliable home internet connection is an average based on local surveys, self-reporting, and the interpretation of "reliable." Pre-K numbers reflect future growth that is expected in the Pisgah Forest area. Davidson River was not included in tallies because long-term plans for that building are

still being evaluated. Science lab numbers for some locations will be reviewed and amended.

Mr. Barger reported that the board of education must review and approve the survey. The board of commissioners must acknowledge receipt and review of the survey, but are not required to approve. The survey does not commit the board of commissioners to funding of any of the needs. The survey is on the board of commissioners' agenda for December 14. ON A MOTION BY MR. GRIFFIN, SECONDED BY MRS. DOMOKUR, the 2020-2021 DPI Facility Needs Survey for Transylvania County was unanimously approved subject to amendments as presented by the finance officer.

10. Superintendent's Update

Dr. McDaris gave the following updates:

- According to the Wall Street Journal, home prices rose in every corner of the U.S. during the third quarter, as the COVID-19 pandemic boosted activity in a way not seen in recent history. Record low interest rates motivated home shoppers to enter the market. Nationwide, the median single-family home price rose 12% from a year earlier to \$313,500. The median price of homes currently listed in Asheville is \$355,000. The median rent in the Asheville area is now between \$1,500 and \$1,600 per month. These prices make recruiting new teachers who need affordable housing a challenge.
- EdNC has an excellent article on the pre-K program in Polk County. Polk County is a high-performing school district. Beginning in 2000, a local philanthropist made pre-K education available at a very low cost to Polk families. They now have multiple pre-K classrooms in every elementary school in the district. Polk County also has a history of an aggressive summer school program that for many years offered enrichment to students in elementary through high school. Bill Miller, former Polk superintendent, once said that a student graduating from Polk County might have as much as an extra year or more of total school time over the course of their academic career.
- Last week saw an increase in the number of school systems in eastern North Carolina (affected by severe flooding) utilizing virtual days. In the west, Burke County has joined Transylvania in calling virtual days as needed for weather closures. Two other western units are considering the same as winter approaches.
