The Transylvania County Board of Education met in regular session at 6:30 p.m. on February 17, 2014 at the Morris Education Center. In addition to four guests, the following board members, staff and media representatives were in attendance:

Chairman McCoy led in a moment of silence and Mrs. Fox led the Pledge of Allegiance. Chairman McCoy welcomed everyone and called the meeting to order. She reported that Mr. Kiviniemi and Mrs. Petit were unable to attend the meeting.

# 1. Approval of Agenda

Chairman McCoy recommended that the Board postpone its discussion of the North Carolina School Boards Action Center (NCSBAC) that had been planned under "Other Items" until a time when all members could be present. There were no objections, and ON A MOTION BY MRS. FOX, SECONDED BY MR. ROGERS, the meeting agenda for February 17, 2014 was amended to remove the NCSBAC topic from "Other Items."

# 2. Public Comment

Mr. Malcolm Johnson expressed concern about the Board's decision to seek bids for artificial turf as discussed at the January 21 meeting. He feels that the proposal that was presented on December 16 shows that Medallion Turf Company has been a reputable and proven provider of artificial turf for a number of area athletic programs, and he feels that seeking additional estimates would only create unnecessary delay for the project. Dr. McDaris responded that there are some positive things on the horizon related to the BHS field that he could not disclose until later. Chairman McCoy assured Mr. Johnson that there is forward progress on the turf project and thanked him for his input.

Mr. Johnson also spoke about the Healthy Living Center that has been proposed by the YMCA and Transylvania Community Hospital. He reported that the published plans for the center include a therapy pool and a large swimming pool; however, the dimensions for the swimming pool are not adequate for competitive swimming events. He urged the Board to speak to the Hospital and YMCA boards and try to get the plans changed to make the pool competition-sized so that swim teams could be reinstated at the high schools.

# 3. Good News Report

Dr. McDaris reported the following items:

#### **NOAA VISITS PFES**

In January, second graders at Pisgah Forest Elementary School enjoyed a weather presentation from Greg Hammer, meteorologist at the National Oceanic and Atmospheric Administration (NOAA). Mr. Hammer shared facts about severe weather, ocean currents, temperature readings and much more. Students were shown different weather instruments, including a weather balloon and a weather clock. One big highlight was a replica of the largest piece of hail to ever fall in the United States. Students and teachers would like to thank Mr. Hammer for visiting their school and providing a fun afternoon of learning.

#### NATIONAL GEOGRAPHIC BEE

On January 14, BMS eighth grader Matthew Sharpsteen was the winner of the school-level competition of the National Geographic Bee for the third year in a row. The next step for Matthew and other school-level winners across the country will be to take a written test on their geography knowledge. The top 100 scorers on the written test in each state will be eligible to compete in their state's Bee. Matthew has qualified for the state competition for the past two years. This year's North Carolina Bee will be held on April 4 in Charlotte.

#### RES STUDENTS LEARN ABOUT WILDLIFE

Recently members of the NC Wildlife Resource Commission spent the day with Rosman Elementary School students helping them learn about area wildlife and lifetime activities. During their normal PE class, students participated in wildlife and outdoors sports including casting, archery, and fish and wildlife identification. Students also got hands-on experience trying to identify North Carolina wildlife by exploring fur, skin, skulls, scat and tracks.

#### ALL-DISTRICT BAND

In January, fifteen Brevard High School students were selected to the All-District Bands. The students auditioned against hundreds of other band members from

across Western North Carolina to earn this honor. The students with an asterisk (\*) placed high enough to audition for the All-State Band in March.

Dr. McDaris reported that because municipal governments and public school systems are not allowed to own stock, the shares will have to be liquidated. Jeremy Gibbs reported that the current market value of the stock is approximately \$248,500. ON A MOTION BY MRS. FOX, SECONDED BY MR. ROGERS, the resolution was unanimously approved.

# 5. Consent Agenda

ON A MOTION BY MRS. FOX, SECONDED BY MR. ROGERS, the minutes from the January 21, 2014 meeting and the personnel report for February 17, 2014 (see attached) were unanimously approved.

# 6. Policy

Dr. Scott Elliott presented for approval the policies that were reviewed at the January 21 meeting. There were no new changes to the policies or questions from the Board. ON A MOTION BY MRS. MCCOY, SECONDED BY MR. ROGERS, the following policies and regulations were unanimously approved:

ON A MOTION BY MRS. MCCOY, SECONDED BY MRS. FOX, Exhibit GCI-E, "Employee Assignments and Transfers," and Exhibit GBM-E, "Staff Complaints and Grievances," were unanimously rescinded.

## 7. School Calendar

Jeremy Gibbs presented draft calendars for the 2014-2015 and 2015-2016 school years as developed and recommended by the calendar committee. He also provided a summary of the most recent state statute requirements for school calendars, notes and feedback from the calendar committee meeting, and a copy of the Henderson County Schools calendar for 2014-2015. Dr. McDaris noted that the Henderson County calendar is a factor due to scheduling crossovers with Blue Ridge Community College, sports and other activities. Mr. Gibbs pointed out there is very little calendar flexibility any longer due to the number of state strictures. He pointed out the following changes to the 2014-2015 and 2015-2016 calendars:

- The previously separate staff and student calendars have been combined into one simpler, easier-to read calendar.
- Each calendar includes one full week of teacher workdays at the beginning of the school year.
- Early release times will all be 12:00 noon. Previously, some releases were at noon and some were at 1:00 p.m. Lunches will continue to be provided on all early release days.
- Teacher workdays will be designated as either optional or required. Also, the six required workdays will be the same for all schools.

Mr. Gibbs reported that some parents have questioned the need to have early releases on the last day before Christmas break and the last day of school. This has been a TCS tradition, but there is concern that some students do not come to school on the last day if

there is an early dismissal. Also, some parents find it a hardship to leave work early and/or find child care on these days. Mr. Gibbs asked the Board for direction as to whether the early dismissals before Christmas and the last day of school should continue.

The Board was very complimentary of the new calendar format. Mr. Rogers asked whether the superintendent anticipates any relief from the state in light of the number of snow days that NC schools have missed so far this year. Dr. McDaris reported that he does not think it likely that the state would forgive any days. However, the new state law that requires 185 days OR 1,025 hours may work in Transylvania's favor by allowing the school system to meet the minimum hour requirement without having to make up every missed day. The law previously required 180 days AND 1,000 hours.

Adoption of the school calendars for 2014-2015 and 2015-2016 will be requested at the next regular meeting. Mr. Gibbs noted that the Board may consider a provisional adoption for 2015-2016 in case the state legislature enacts additional calendar law changes between now and then.

# 9. FY15 Budget

Norris Barger presented the latest information and draft documents for the FY15 budget. He reported that he had no significant new budget information since the state finance officers' meeting was canceled last week due to snow. He reported that the governor has proposed a pay increase for beginning teachers, but it is not known how that will be structured or exactly who will be affected. He reported that preliminary projections indicate a necessary increase of 2.1% in county appropriation; however, these projections are very soft due to the many unknowns in state and federal funding.

Mr. Rogers reported that he had done some calculations that show an increase of \$400,000 in support and development expenditures from FY12 to FY13. He asked if it would be possible to take some of that \$400,000 and use it to increase teacher supplements and address salary structures for others. Mr. Barger said that the Board could certainly look at that, but first he would need to provide a detailed report showing the activity within each of the different funds that comprise the support and development category in order for the Board to have a true picture.

Dr. McDaris reported that the administration is looking at potential staffing needs in AIG, special education, social studies, and school nurses. Mr. Barger reported that he has compiled preliminary capital priority lists based on input from principals, and it is likely that these lists will change after the school facility tours. Mr. Rogers asked about repayment of the BHS lighting upgrade. Mr. Barger explained that the Board is repaying the county over a five-year payment schedule.

Mr. Rogers asked for an update on staff vehicles. Dr. McDaris reported that the three staff cars (2006 Impala, 2006 Taurus and a 2004 Taurus) are in near-constant use. A fourth staff car was totaled last year when it was hit in a rear-end collision. There is also a service truck that is used for checking roads and an older car that DRS uses for home visits and other student-related needs. All of the staff vehicles have very high mileage. Mr. Barger reported that a car is on order to replace the one that was totaled. Dr. McDaris noted that the district will be getting a new yellow bus this year via state funds.

#### 10. Superintendent's Update

Dr. McDaris gave the following updates on new and ongoing issues for the 2013-2014 school year:

- The superintendent and others attended the *Emerging Issues in Education Forum* that was held in Raleigh on February 10-11. The topic for the forum was "teachers and the great economic debate."
- The State Board of Education has approved alternative assessments for the Read to Achieve program. The alternative assessments may help to improve the current testing overload.
- A North Carolina judge has refused to dismiss the case in the Wake County lawsuit that challenges the constitutionality of vouchers for private schools.

Dr. McDaris reported that if no more days are missed, it may be possible to avoid having to make up February 13 and 14 based on the state requirement of 185 days OR 1,025 hours. If more days are missed, other possible make-up options could be June 5-6, Saturdays, Good Friday, or a portion of spring break.

## 12. Public Comment

On behalf of the Jewish community, Mr. Norm Bossert expressed thanks and appreciation to teacher Kelly Muse for inviting Mr. Walter Ziffer to speak to her students about the Holocaust.

# 13. Other Items

Mr. Rogers stated that early discussions regarding a possible bond referendum have focused on a preliminary estimate of \$18-20 million. He stated that he has done an analysis of high school enrollment data from FY14 through FY23 which shows enrollment would drop 20% within the next 6-7 years. That being said, he said that he would not be comfortable supporting a bond issue of that size without having further study of the schools' makeup. He believes that the Board needs to consider whether there are things that can be done to offer better academics and education for students. He believes that if enrollment at Rosman drops by almost 100 students as he has predicted, the system would be either limited in the courses it can offer or the cost of educating those students would skyrocket. He predicted that RHS would become the size of Andrews High School and that BHS would become a 1A school. He reported that his calculations show costs have increased by \$500 per student over the last three years, and he fears that number will only escalate as enrollment decreases. Mr. Rogers distributed handouts charting his projections. He stated that he would like for the Board

to consider hiring an outside, unbiased source to perform a study aimed at determining the best way for the district to spend its resources.

Chairman McCoy thanked Mr. Rogers for his efforts. She stated that she believes the county is working harder than ever before toward economic development, and should those efforts progress in a positive way, school enrollment would be affected. She stated that this matter should be a discussion for the full board, and added that a bond discussion is already planned as part of the larger discussion with the county commissioners that will take place at the joint meeting on February 25. Mr. Rogers stated that he agrees with the need for a full board discussion, but feels that he cannot sit with the Board of Commissioners and act like he is in favor of something when he believes there is a need for serious discussion. Chairman McCoy stated that if the Board cannot be unified in its approach toward a possible bond, then there does indeed need to be a serious discussion. Mr. Rogers stated that he had been fully on board with pursuing a bond until he ran his numbers. Chairman McCoy stated that in her opinion, there is more that goes into the type of decision that Mr. Rogers is talking about than just looking at enrollment data. Mrs. Fox agreed. Mrs. McCoy stated that she would share Mr. Rogers' data with Mr. Kiviniemi and Mrs. Petit.

#### BY THE GOVERNOR OF THE STATE OF NORTH CAROLINA

#### A PROCLAMATION

WHEREAS, every day in North Carolina, over 13,000 school buses carry more than 790,000 students to and from school; and

WHEREAS, without school buses and school bus drivers, many public school students would not have safe, reliable transportation to and from school; and
