TCS DRIVER EDUCATION COURSE AVAILABLE ONLINE

Students in Transylvania County Schools now have a convenient online option to begin working toward their learner's permit and driver's license. The new online course is a great option for students and families who prefer not wait for a regularly scheduled sit-down driver's education class. The 30-hour course is provided by Mountain Professionals, Inc., which provides driver education for students throughout western North Carolina, including Transylvania County. Registration for the online program costs \$60, compared to \$40 for the regular classroom course offered at Brevard and Rosman High each year. Students must be 14½ years old to register. TCS VIRTUAL DAYS FEATURED ON DPI WEBSITE

The North Carolina Department of Public Instruction recently featured Transylvania County Schools' Virtual Days initiative on its monthly "Celebrate NC Schools" website: <u>http://www.ncpublicschools.org/celebrate/feature/</u>. So far this winter, students have had two virtual days. The district had five in 2015-16, the first year of the initiative. In each of the two previous years, Transylvania schools were closed for eight days because of snow - a challenge that led the district to launch the innovative Virtual Day alternative. Local feedback on the Virtual Day initiative has been very positive, and other mountain school districts are sending inquiries as they consider launching similar programs.

SEVEN AREA WRESTLERS QUALITY FOR STATE CHAMPIONSHIPS

Five members of the Brevard High School wrestling team qualified for the state championships at the recent 2A regional tournament: Daniel McJunkin, Cole Galloway, Tanner Ellenberger, Logan Roth, and Keenan Hawkins. Ellenberger took first place in the tournament, with his championship

giving him 100 career victories. Two Rosman wrestlers, Tanner Whitman and Cody Swangim, took top honors. Whitman finished second at the 1A west regionals and Swangim took first place in the 170 pound division. Tanner tied Coach Wesley Whitman's school record with 151 total wins and could surpass that at the state finals. *(Transylvania Times, Feb. 13, 2017)*

ALL EYES ON BHS TRACK

Brevard High School runner Noah Graham picked up another three state titles, bringing his total to seven, after leading the Blue Devils Men's Track Team to a third-place finish at the 1A/2A Indoor Track State Championship meet. The BHS track team also did very well at the prestigious David Oliver Classic, a two-day invitational meet showcasing some of the best runners in the region.

RES TEACHERS ATTEND "LEADER IN ME" SYMPOSIUM

On February 16-17, five Rosman Elementary School teachers, Michelle Cabe, Laura Russo, Laura Sullivan, Crystal Whitman and Jennifer Worley, attended a "Leader in Me" symposium in Spartanburg, SC. The group heard inspirational speakers, talked with teachers and school leaders, and visited schools that are implementing the "Leader in Me" program. Rosman Elementary is exploring the "Leader in Me" concept as a potential school theme and program to better reach and teach its students.

2A WOMEN'S CROSS COUNTRY STATE CHAMPIONS

4. Former Students in the Military

The board reviewed the list of former students from Brevard High School, Rosman High School, and Davidson River School who are currently serving or have previously served in the U.S. Military. There were no new names on the list.

5. <u>Consent Agenda</u>

ON A MOTION BY MR. KIVINIEMI, SECONDED BY MRS. MCGAHA, the minutes of the January 17, January 26, and January 27, 2017 meetings and the personnel report for February 20, 2017 (see attached) were unanimously approved.

6. Instructional Update

Dr. Jeremy Gibbs gave an update on school dropout data for the 2015-2016 year. He reported that the number of dropouts declined from 38 students in 2014-2015 to 22 students in 2015-2016. This represents a 42.1% decrease over the course of one year. Dr. Gibbs reported that most of the students who drop out of school face challenges that typical middle class families do not. Board members were pleased to see the lower dropout rate and expressed thanks to all of the teachers and specialists who work with at-risk students.

7. <u>Policy</u>

Brian Weaver presented 11 policies from the 6000 Series Part B (Transportation Services) for approval and three old policies for rescission. He reported that there had been no changes to the policies since the first reads in January. There was no discussion, and ON A MOTION BY MRS. MCGAHA, SECONDED BY MR. GRIFFIN, the board unanimously adopted the 11 new policies and rescinded the 3 old policies as indicated below:

Mr. Weaver presented 19 new policies from the 6000 Series Part C (Purchasing, Equipment, Materials, and Supplies) and 8 old policies as first-read information. Mr. Kiviniemi stated that he feels the goal of 4% participation by minority-owned businesses that is stated in policy 6402 (Participation by Historically Underutilized Businesses) is too low, and suggested changing the goal to 10%. Mr. Barger reported that 4% is a realistic goal for a rural school system in WNC, where there are fewer minority-owned, femaleowned, and disabled-owned businesses in general. Mr. Donnahoo reported that larger systems such as Buncombe County only have goals in the 4-6% range. MR. KIVINIEMI MADE A MOTION to change the 4% goal to 7% in line 9 of policy 6402. MRS. WELLBORN SECONDED THE MOTION. Board members discussed the proposed change. Mrs. McGaha expressed concern about establishing a goal that could not realistically be met. Mr. Griffin noted that most contracts have to be awarded to the lowest qualified bidder. Mr. Donnahoo offered to survey other school systems regarding their percentage goals and send the information to Dr. McDaris. MR. KIVINIEMI WITHDREW HIS MOTION AND MRS. WELLBORN WITHDREW HER SECOND pending more information from the board attorney.

Mr. Weaver addressed other questions from the board regarding local procedures related to purchasing, equipment and supplies. ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. GRIFFIN, the 19 new policies and 8 old policies listed below were unanimously accepted as first-read information. Action on the policies will be requested in March.

8. <u>School Calendar for 2017-2018</u>

Brian Weaver presented the recommended school calendar for 2017-2018 as first-read information. He reported having good representation from parents, staff, and others on the calendar committee and good feedback from schools on the initial drafts. Mr. Kiviniemi reported that he had attended the calendar committee meetings and was impressed by the cooperation among different grade levels in developing a calendar that all could agree on. Mr. Weaver reported that Transylvania County Schools did qualify for a state waiver that would allow school to start earlier than August 28. The first day for TCS students will be August 23. Chairman McCoy asked if there had been any discussion about moving the designated early release days away from Wednesdays. Mr. Weaver reported that it had been discussed; however, the committee agreed that because of the number of activities and events scheduled on other days, Wednesdays remain as the best option. Approval of the 2017-2018 calendar will be requested at the next regular meeting.

9. Resolution Supporting Local Control of School Calendars

As requested at the January meeting, the superintendent presented a resolution for the board's consideration supporting local control of school calendars. The board approved of the draft as presented, and ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. GRIFFIN, the unanimously adopted the resolution supporting the efforts in the North Carolina House of Representatives for local school calendar control and requesting that local control over school calendars be returned to local boards of education (see attached). The board asked for copies of the resolution to be sent to Senate and House legislators. Mr. Kiviniemi and Mrs. Wellborn expressed thanks to Representative Cody Henson for his efforts in introducing a bill to return local calendar control.

10. Annual Financial Report for 2015-2016

Norris Barger presented the Transylvania County Schools annual financial report for the fiscal year July 1, 2015 through June 30, 2016 and the auditors' compliance report to the board. The audit disclosed no material weaknesses or significant deficiencies in internal controls; no instances of noncompliance with laws, regulations, contracts or grant agreements; and no findings or questioned costs in any funds. Mr. Barger pointed out the ongoing dwindling of fund balance and stated that the only way to reverse the trend is to increase revenue or decrease expenditures. Mr. Kiviniemi remarked that while the school system has to use its fund balance for operating expenses, the county's revenues continue to grow. Chairman McCoy congratulated Mr. Barger and his staff for the excellent audit and careful stewardship of resources.

11. FY18 Budget

Norris Barger reported there was no new budget information from Raleigh. He noted that the state has a reported \$550 million budget surplus, but education may not see any benefit. Two big concerns are the impact of the Senate's class size ratio bill and the possibility of changes to the state funding formulas. The House passed HB13 unanimously, but it is unknown what may happen in the Senate. Chairman McCoy reported that she had spoken with Chairman Chapman and he had indicated the county commissioners would be willing to support a joint resolution in support of HB13.

12. Board Member Compensation

At the January meeting, Vice Chairman Kiviniemi presented a comparison of compensation levels for members of the board or education and members of the board of commissioners and indicated that he would introduce a motion to increase the board of education's compensation. Mr. Kiviniemi reported that he had since decided not to offer a motion at this time as any change would not go into effect until July 1. He presented a comparison of compensation amounts in 19 western counties that shows Transylvania tied for 17th place. He discussed the wide range in earnings and attributed the disparity to the fact that school boards must ask county commissioners for increases. Mr. Kiviniemi reported that he is gathering more research on how compensation levels affect the way governmental bodies perceive each other and would consider making a motion at a later date.

13. Report from "School Board 101"

Mrs. Wellborn gave a report from the North Carolina School Boards Association "School Board 101" conference that was held on January 23-24, 2017 in Raleigh. She reported that the two days of training were interesting and informative, with topics including board member roles and responsibilities, ethics, public school finance, education law, contracts, common liability issues for school districts, and policy development.

14. <u>Superintendent's Update</u>

Dr. McDaris gave the following updates:

- Work continues by the superintendents' statewide task force on the revised ESSA (Every Student Succeeds Act). The task force has weekly conference calls and several face to face opportunities with legislators this spring.
- The *NC Public School Forum* has released information on the state legislature's opportunity scholarship program which provides taxpayer funded vouchers to

private schools. The top three private schools accepting the vouchers as authorized by the North Carolina General Assembly are:

- a. Trinity Christian School in Fayetteville (\$958,440)
- b. Word of God Christian Academy in Raleigh (\$918,074)
- c. Greensboro Islamic Academy (\$882,840)
- House and Senate budget proposals will be unveiled in coming weeks and months. There is concern that lawmakers may propose a block grant for principal pay in lieu of reconnecting principal pay to the teacher salary schedule. The teacher salary schedule is a better option for ensuring a career path for teachers who want to move into school leadership roles.
- The House K-12 Education Committee considered legislation last week to form a task force that would look at changing funding formulas for school systems. The task force would consider changing from the current allotment-based funding formula to one that is determined using a weighted-student formula.
- A bill was recently filed to make major changes to the way the State Board of Education is composed, including electing members instead of appointing them, giving the state superintendent voting rights, and removing the state treasurer from the board. House Bill 133 proposes amending the state constitution so that board members are elected by congressional district and serve four-year terms. Under current law, board members are appointed by the governor, confirmed by the legislature in joint session, and serve eight-year terms.

Resolution Supporting Local Control of School Calendars 2017

WHEREAS, the North Carolina General Statutes give local boards of education powers of supervision and control of local school systems; and

WHEREAS, local control over establishing school calendars is an integral component of school system supervision, administration, and operation with which local boards of education have been vested; and

WHEREAS, state law has arrogated local control by imposing a one-size-fits-all decree on how school calendars are to be set; and

WHEREAS, by arrogating local control, the current calendar law has led to the calendar for high schools, community colleges and universities being out of alignment by approximately two weeks, causing scheduling problems as college courses now begin before high school students complete January final exams; and

WHEREAS, the current school calendar law has created a situation where fall semester cannot be completed before the winter break, forcing exams to be administered after the break, and meaning that students get no break without assessments/assignments pending; and

WHEREAS, our great nation, the United States of America, prudently looks to our great traditional public schools as the foundation for economic success and maintaining a competitive lead over other nations of the world; and

WHEREAS, the competitive edge that makes America unique among other nations includes the support for our traditional public schools' efforts in designing a calendar that best prepares our students to be the next generation of leaders for our nation; and

WHEREAS, it is well documented through multiple studies that children experience learning loss during the summer months when they are away from the classroom and not engaging in educational activities, a phenomenon known as summer learning loss and which has a disproportionate impact on low-income children; and

WHEREAS, long breaks can also negatively impact child nutrition, as low-income children who have access to regular meals at school through the free and reduced priced meal program may not have access to regular meals at home; and

WHEREAS, the schedule for fall athletics has not changed to coincide with the state-mandated school calendar, meaning that most schools have played two football games before school even begins; and

WHEREAS, restoring local control of school calendars will allow local boards of education to best meet the unique educational needs and school calendar preferences of the children and families within their communities while allowing for innovative experimental approaches to dealing with summer learning loss;

NOW, THEREORE, BE IT RESOLVED that the Transylvania County Board of Education supports the efforts in the North Carolina House of Representatives for local school calendar control and requests that local control over school calendars be returned to the local boards of education.
