The Transylvania County Board of Education met in regular session at 6:30 p.m. on March 2, 2009 at the Morris Education Center. Present were Mike Rogers, Chairman; Chris Whitmire, Vice Chairman; Tawny McCoy, and Shelia Norman. Also present were Dr. Sonna Lyda, Superintendent; Jenny Hunter, Administrative Assistant; and approximately 10 staff, guests, and media. Mrs. McCoy gave the invocation and Mr. Whitmire led the Pledge of Allegiance. Chairman Rogers gave the welcome and called the meeting to order.

1. Public Comment

Chairman Rogers gave a follow-up that the City of Brevard is looking into ways to improve safety at the Brevard High School student crosswalk.

2. Good News Report

6. Policy

The Board reviewed revised Policy GCPA (Reduction in Force). Mrs. Norman pointed out additional changes that need to be made to the policy. The policy will be further revised and returned on March 16 for approval.

ON A MOTION BY MR. WHITMIRE, SECONDED BY MRS. MCCOY, revised Policy JEC (School Admissions) was approved as presented.

ON A MOTION BY MRS. NORMAN, SECONDED BY MRS. MCCOY, revised Policy JHCB (Immunization and Health Requirements for School Admission) was approved as presented. ON A MOTION BY MR. WHITMIRE, SECONDED BY MRS. NORMAN, Policy JHCB-R (Inoculations of Students) was rescinded.

ON A MOTION BY MRS. MCCOY, SECONDED BY MRS. NORMAN, revised Policy IIC (Field Trip Approval and Cancellation) was approved as presented.

7. District Data Notebook Update

David Sutton presented the following strategic indicator updates:

- SAT Results This is a new indicator and will become a regular update. In 2008, the TCS average score was 1539, compared with the state average score of 1489 and the national average of 1511. In overall scores, TCS has exceeded the state and national averages since 2001. Chairman Rogers attributed this trend to our high quality teachers and staff and the district's high standards.
- Annual Local School Finance Study Data For 2008, Transylvania County ranked 27th out of 100 counties in actual funding effort. In relative effort (what the county is able to pay), the school system ranked 82nd out of 100. In 2008, the local per pupil spending in TCS was \$2,727. The state average was \$2,719 per pupil. In local revenue capacity (how much could have been spent had the county taxed at the state average tax rate), Transylvania could have spent \$7,930 per child. Transylvania ranks in the top 10% of counties in spending ability per child, but in the bottom 20% in actual spending per child.

8. Child Nutrition Update

Carolyn Gordon gave an update on the Child Nutrition program. The program projects a deficit of \$140,000 in FY09. They are requesting a minimum of \$50,000 and a maximum of \$100,000 from local funds to stabilize operations for FY10. All North Carolina CN programs are expected to lose money this year because rising food and labor costs have outpaced federal reimbursement. Many CN programs in this area are already receiving local assistance. In addition to increased food and labor costs, economic factors play a role. Free/reduced rates in Transylvania County are at their highest ever (over 50%). Higher free/reduced rates equal lower sales revenues. Ms. Gordon noted that there

might be some relief on the way from the federal government, but exactly when and how much are unknown. The Child Nutrition department proposes using a combination of a 25-cent lunch price increase, local subsidy, and federal reimbursement rate increase to balance its budget for FY10.

Ms. Gordon described the various money-saving methods being employed such as long-term purchasing contracts (when possible), re-evaluations of paper and plastic products, comparison price shopping and food substitutions, and re-negotiation of food vendor contracts.

Board members had questions about indirect costs. Ms. Gordon explained that these are costs paid back to the school system for operational expenses that are paid for by the school system such as electricity, water, etc. Every federal program may be charged indirect costs provided that the program is making money.

Board members were very concerned about the impact of a price increase on families that are struggling financially. Chairman Rogers stressed his preference to increase the local contribution rather than raise school lunch prices. Mrs. Gordon suggested going ahead and planning for the price increase, and then, based on the hoped-for federal assistance, either reducing or eliminating the increase.

Chairman Rogers suggested that Board receive quarterly updates from Child Nutrition. All agreed.

9. New Web Site Preview

Donys Merrill gave a preview of the new TCS Web site www.tcsnc.org. The site goes live on March 2. The new design provides improved consistency of format, better ease of use, and a more interactive environment for teachers and students. All TCS e-mail addresses will be changed to reflect the new domain. The old e-mail addresses will also continue to work indefinitely. The new site has received many positive reviews from faculty and staff. The Board commended Mrs. Merrill and the technology staff for all their hard work on the new site.

10. FY10 Budget

Dr. Lyda recommended the following changes to the FY10 budget needs list:

- Remove the teacher supplement increase (\$92,946); math teacher position (\$50,759); school nurse position (\$52,668); and technology facilitator position (\$51,650) and move those amounts into teacher and teacher assistant positions to offset potential state cuts.
- Increase Child Nutrition amount to \$100,000.
- Reflect dollar figure for the retirement increase (\$9,603).
- Remove SRO item.
- Reflect 2% COLA increase for certified positions only.

These changes would bring the bottom line amount (approximately \$591,000) to the same level as last year. It was the Board's consensus to make the changes as recommended. The changes will be reflected in the next draft.

Chairman Rogers invited Allie Perkins to share her comments regarding the budget or any other topic. Miss Perkins reported that as a graduating senior, she would have

preferred to have a calendar that would have allowed first semester exams before Christmas.

Norris Barger presented his recommended cuts for capital outlay projects. The cuts would reduce the amount to be requested from the county from \$1,874,025 to \$979,945. He reported that he had selected to keep only those items that represent basic safety needs or items that had been noted in fire and safety inspections. All other non-critical items would be deferred at least one year. Members were concerned that deferring so many projects this year would make the FY11 request too large. Mr. Whitmire also expressed concern that asking the commissioners for so little this year would set a negative precedent for future years. All agreed that the Board would ask for the money back and a return to normal funding levels when the economy improves.

Board members had several concerns about the items being recommended for cuts. Chairman Rogers recommended further discussion of the projects school by school at the next meeting. Dr. Lyda reported that the capital outlay priority list should be ready for first read at that time. She stated that although the capital proposal seems severe, it is important to remember that every county department except for the school system had to return 5% of their budgets this year.

Mrs. McCoy conveyed her appreciation for the impressive upkeep of school facilities as evidenced on the school tours.
