The Transylvania County Board of Education met in regular session at 6:30 p.m. on March 18, 2013 at the Morris Education Center. Tawny McCoy, Chair; Cindy Petit, Vice Chair; Sue Fox; Ron Kiviniemi and Mike Rogers were present. Also present were Dr. Jeff McDaris; Jenny Hunter; Norris Barger; Dr. Kim Elliott; SRO Andrew Shook; Meredith Licht; Jeremiah Reed, Transy/vania Times; and approximately 18 guests. Mrs. McCoy led in a moment of silence and Mrs. Fox led the Pledge of Allegiance. Chairman McCoy welcomed everyone and called the meeting to order.

## 1. Approval of Agenda

Chairman McCoy suggested that the Board have public comment before convening in closed session. ON A MOTION BY MRS. FOX, SECONDED BY MRS. PETIT, the agenda for March 18, 2013 was unanimously revised to move item no. 2, closed session, after public comment.

## 2. Public Comment

Marcus Dodson, parent, encouraged the Board to move forward with scheduling the planned public input sessions regarding a modified school calendar and also to include magnet schools in the discussions. He suggested making the district calendar committee more representational by having half of the membership comprised of parents and students and half comprised of school employees. Thirdly, he suggested that the Board consider implementing a process of visioning and five-year strategic planning in order to improve the budget process.

## 3. Closed Session

ON A MOTION BY MRS. PETIT, SECONDED BY MR. ROGERS, the Board went into closed session at 6:37 p.m. to discuss the possible acquisition of real estate, pursuant to N.C.G.S. § 143-318.11(a)(5). Present in the closed session were Mrs. McCoy, Mrs. Petit, Mrs. Fox, Mr. Kiviniemi, Mr. Rogers, Mr. Barger, and Dr. McDaris. Following discussion, ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. ROGERS, the Board authorized Dr. McDaris and Mr. Barger to explore ways in which the Board might
purchase a particular property. There was no further action, and ON A MOTION BY MRS. MCCOY, SECONDED BY MR. KIVINIEMI, the Board returned to open session at 7:25 p.m.

## 4. Good News Report

Dr. McDaris recognized the student artwork from RHS that was on display in the board room and reported the following items:

## NCAEOP ANNUAL CONFERENCE

Fourteen office support professionals representing the schools and central office traveled to Greensboro on March 6-8, 2013 for the North Carolina Association for Educational Office Professionals (NCAEOP) Annual Conference. Dr. Jeff McDaris, Dr. Scott Elliott, and Mr. Jeremy Gibbs joined the group for portions of the conference. Jenny Hunter (MEC) received her PSP Professional Renewal Certificate and Leigh Anne McJunkin (BHS) represented the Western Region as the District 1 EOP of the Year. In addition, RHS graduate, Devon McIntosh, was awarded a \$1,000 Staples Scholarship for outstanding academic achievement and commitment to furthering her education. Devon is in her first year at UNC-Wilmington.

At its awards dinner last month, the United Way of Transylvania County presented the Gold Award to Transylvania County Schools for outstanding service to the community. In addition, TCS was honored for having the highest dollar increase in payroll deductions for the 2012-2013 United Way campaign.

## State Science Fair Winners

## DAnish Exchange Students at BHS

Brevard High School hosted 27 Danish exchange students and two visiting teachers in March. The exchange students have been attending classes at BHS and staying with families in the community to learn more about American culture. They have enjoyed bluegrass music, hiking in Pisgah National Forest, watching high school baseball games and shopping. The group visited the Biltmore House on March 15, and will visit Brevard College on March 19. A closing ceremony will be held at BHS at 7:00 p.m. on March 20, and the group will fly home on March 21. Brevard High School Principal Jeremy Gibbs introduced the Danish teachers, eight of the exchange students and the BHS staff and host families who were in attendance. The teachers described their experiences with the exchange program over the years and invited TCS to visit their country next year.

## 5. Former Students in the Military

The Board reviewed the list of former students from Brevard High School, Rosman High School, and Davidson River School who are currently serving or have previously served in the U.S. Military. There were no new names.

## 6. Consent Agenda

ON A MOTION BY MRS. PETIT, SECONDED BY MR. KIVINIEMI, the minutes from the March 4, 2013 meeting, the personnel report for March 18, 2013 (attached), and the memorial report for March 18, 2013 (see below) were unanimously approved.

The book, Mountain Tales, by John Parrish, has been placed in the Rosman High School media center in memory of Becky N. Wilson, mother of Sharon Eubanks. Sharon is a bus driver at RHS.

The book, Hatchet, by Gary Paulsen, has been placed in the Rosman High School media center in memory of Billy F. Payne, father of Rae Parker. Rae is an instructional technology facilitator at RHS.

## 7. FY14 Budget

Norris Barger presented a first draft ranking of board priorities for capital outlay needs systemwide. The report showed total projected costs of $\$ 2,687,000$ for FY14 and $\$ 2,169,000$ in county appropriation. The following items were discussed:

- Mr. Barger reported that a new leak has developed in the ceiling of the BHS cafeteria. Repair efforts have revealed that the beams between the curved arches near the glass windows are rotted. Mr. Barger has therefore added $\$ 90,000$ to the estimated cost for roof repairs at BHS, increasing the total to \$220,000.
- Mrs. Petit noted that the report shows almost $\$ 1$ million in recurring costs and another million in needed repairs, which is further evidence of the Board having to "kick the can" over the last four years.
- Mr. Barger reported a current total of \$455,000 in unassigned capital fund balance, of which approximately $\$ 100,000$ would be appropriated for FY14.
- The Board discussed some items they would like to see moved up in priority and discussed the dilemma of choosing between security items and other expensive
items such as HVAC systems and roof replacements. Chairman McCoy expressed hope that the Board would get some indication of the level of funding that could be expected before having to finalize the list. Mr. Barger noted that the commissioners have traditionally requested the Board's prioritized list before deciding on the funding allocation. Mr. Rogers stated that now is best opportunity for the Board to get the funding needed to improve front security at the schools.
- Mr. Rogers asked whether any of the projects listed could be performed by local jail detainees or Job Corps students in order to save money. Mr. Barger reported that prisoners are sometimes used for projects such as exterior painting and weeding that do not require specialized tools or skills. He noted that prisoners are never allowed to be on campus when students are present. Mr. Kiviniemi indicated that the Job Corps had not accepted any new students this year.
- Dr. McDaris suggested creating two priority lists for comparison purposes, one for security items and one for repair items. Board members were in agreement that having separate lists would be helpful in evaluating needs.
- Dr. McDaris reported that the county typically wants to have the Board's budget request by the first week of May. All members agreed that further study and discussion of priority needs would be needed at the next meeting on April 15.
- Mr. Barger pointed out that if the schools were to be funded at the same level as last year, and the Board were to add lottery proceeds and fund balance, the capital outlay allotment would cover only through item number 5 on the priority list. The list currently includes over 160 items.
- Mr. Rogers commended Commissioners Mike Hawkins and Page Lemel for taking the time earlier this month to tour the schools and view firsthand the schools' facility needs.

Dr. McDaris reported that the 2013 graduation ceremonies would likely be scheduled for the first weekend in June.

## 9. Public Comment

Teresa Hutchins, parent, stated that she was struck by how much money the Board is considering allocating to improve front access at the schools considering how, in her opinion, all campuses have other more glaring safety vulnerabilities.
10. Other Items

ON A MOTION BY MR. ROGERS, SECONDED BY MR. KIVINIEMI, the Board unanimously approved Hugh Green as a volunteer assistant coach for 2013 BHS softball.

Mr. Rogers stated that some districts have added minutes to the school day as way to build more instructional time into the school calendar, and asked whether the Board would consider this option for Transylvania County Schools. He calculated that adding 15 minutes per day could add 7 days to the calendar. Dr. McDaris reported that the Board and administration have discussed this option previously; however, teachers have indicated that adding a few more minutes per class would not be as effective qualitatively as having additional full instructional days. Mr. Rogers asked TCAE President Meredith Licht if she had to make a choice between adding minutes per day or having firstsemester EOC exams in January, which option she would choose. Mrs. Licht stated that while it would be good to be able to have high school EOCs before Christmas, having fewer instructional days would not be the solution. She indicated that quality time is more important in terms of teaching and learning.

There was no further business, and ON A MOTION BY MRS. FOX, SECONDED BY MRS. PETIT, the meeting was adjourned at 8:40 p.m.
