# 2. <u>Good News Report</u>

Dr. Lisa Fletcher shared the following good news items:

# State Wrestling Champions

Congratulations to Brevard High School wrestlers Jaxon Turner and Ray Laney for winning the State Championships in their respective weight classes. Jaxon was the 165-

Ib state champion and Ray was the 190-Ib state champion. This is only the second time that Brevard High has had multiple state champions in the same year. Jaxon and Ray are the 22<sup>nd</sup> and 23<sup>rd</sup> individual state champions in Brevard wrestling history. Jaxon is the 5<sup>th</sup> Brevard wrestler to ever win multiple state championships. Congratulations also to their coaches Chad Laney, Joe Ellenberger, and Nathan Turner. The board invited Jaxon, Ray, and their coaches to come to the front and be recognized.

#### Honors Bands Recognitions

#### 3. Public Comment

Chairman Jackson reported that 13 people had signed up to speak and asked for a motion to expand the time to 3 minutes. MR. O'NEILL SO MOVED, MR. WIENER SECONDED, and the motion was unanimously approved. Mr. Jackson reviewed the guidelines for public comment.

**Katrina Clark** – I am a retired school teacher. I want to say thank you for so much for naming Amanda Lewis as Principal of the Year. I know her to be extremely educated, talented, smart and compassionate. Thank you for employing people like Anna Galloway and Ashley Dickson. They are a part of the school system's student support team that has been helping a family whose child has received an unusual medical diagnosis and are going through a hard time. They have been able to navigate and find educational options for the child. Thank you for placing Carrie Norris at Brevard Middle School. It's been wonderful having her there. Thank you for whoever is on the media team for the school system. One of the joys of my day is to look at Instagram and see all the incredible things that are happening in the schools. Thank you for respecting parents and knowing that each parent needs to be one to make decisions about what is appropriate for their child to read. And if you have a parent that doesn't feel good about a reading material, to respect that parent and make sure that the media center personnel and the teacher make sure that child does not see the reading material that the parent objects to. But on the flip side, that you respect all parents, and if a parent does not have an issue with material, that you respect that, too.

**Sarah Grace Montgomery** – I am a parent at Brevard Elementary School and also active with the OPT there. I want to celebrate the spring basket raffle fundraiser at BES. Tickets are still on sale and will be drawn on Thursday night. Thirteen incredible baskets of goods will be raffled off due to the generosity of our parents and many local businesses (read long list of donors). Thank

you and please support our local businesses because they are supporting our children and our schools.

Olivia Hankey, Leo Stevens, and David Queen - We are from the Brevard High school newspaper club. The Broadcaster. We want to speak to you about the education capital report. Regarding the presence of black mold and other issues affecting our school's environment, we would like to remind the board that they must consider the wellbeing and safety of students, teachers and staff. To stabilize and preserve Transylvania County Schools facilities, significant investments are required over the next 10 years. The report did not address improving items related to educational adequacy, functionality or space utilization, and primarily looked at core infrastructure. Improving stability is crucial, but we shouldn't stop there. The report points out that we overlooked important aspects, like how well our schools meets educational needs, how effectively they function, and how efficiently space is used. We implore the board to take decisive action to address the issues based on our fellow students, teachers and staff, to allocate resources and attention to ensure that our school facilities are safe and conducive to learning, and to improve our schools for future generations. We are committed to informing our community about the importance of addressing issues and advocacy. We urge the board to collaborate with students, teachers and community members to develop and implement an effective solution for all stakeholders. Lack of action on these pressing issues has impacted our learning environment, contributed to the erosion of student mental health, and diminished trust in the board's commitment to prioritizing student safety and welfare. We look forward to seeing these issues being addressed.

**Meredith Licht** – I am an English teacher at Brevard High School. Word on the streets and in cyberspace is that a group of guardians and community members would like to have John Green's *Looking for Alaska* removed from one of our middle and high school libraries, along with the librarian. I would like to share some of the author's thoughts on the banning of his book. He says:

"Text is meaningless without context and what usually happens with Looking for Alaska is that a parent chooses one particular page or passage of the novel to review, and then the book gets banned without anyone who objects to it having read more than that particular passage. The scene in question involves a very awkward and ultimately failed attempt at oral sex which is described in very cold and clinical language. In fact, the entire passage includes only one adjective, 'nervous.' In the next scene, two characters have a much more sensuously described and passionate, but less sexually explicit, interaction. In context, the novel is arguing that emotionally intimate kissing can be a whole lot more fulfilling than emotionally empty sex. Teenagers are critically engaged and thoughtful readers and they do not read any book, like for instance The Outsiders, and think 'I should join a gang,' or Divergent and think 'I should jump on moving trains.' That type of prescriptive reading seems only to happen inside the offices of school superintendents. Looking for Alaska is not pornographic and I don't think its readers find it titillating. But it is not up to me [John Green] whether that book or any book is in the school library, because I am not a teacher or a librarian-the highly trained, criminally underpaid professionals that we employ to make those decisions. I don't think publicly funded education exists primarily for the benefit of parents or even primarily for the benefit of students. It exists for the benefit of the social order. We are all better off with a better off with a well-educated, well-informed population because that population is more likely to start successful businesses and develop treatments for cancer. That is why everyone pays taxes to fund public schools and libraries, regardless of whether you personally use the library or have kids in school. I think teachers and librarians know more about teaching and librarianship than I do, and I believe that they must be allowed to do their jobs while serving the whole public. I don't believe that books, even bad books, corrupt us. I believe books challenge and interrogate. They give us windows into the lives of others and give us

mirrors so that we can better see ourselves. And ultimately, if you have a worldview that can be undone by a novel, let me submit—the problem is not with the novel."

Alicia Reiner – I am a BHS parent. I want to thank the BHS administration for working with my student as an individual to create a learning situation that fits them individually. I want to thank the teachers for all of their hard work and hours of commitment in individualizing teaching to fit the student. They are engaging in projects to employ critical thinking and instilling a passion for learning that will last a lifetime. A lot of good work going on out there, a lot of good mentoring and coaching. Our students are really influenced by these teachers and that is a good thing. They are good people. The bus drivers too. Even though I am a parent, I know it takes a village. I also want to give a shout-out to the JROTC program. They are working with kids who range from certain that they want to join the military to just exploring, and they are building camaraderie, teamwork, leadership, discipline and a whole bunch of PT. That is exactly what they need. They will be the leaders and the citizens of tomorrow. A shout-out to TC Strong for supporting students and building a strong and healthy community in the face of difficulties. I would like to see the board support time for the staff at BHS to engage in the team building that TC Strong does for mental health training. That sets the stage for students to learn as well. I have been really moved by the recent stressors on our community and would like to see the board and administration engage in building us stronger. I do want to see facility upgrades. They are desperately needed to improve student mental health and learning environments.

**Harvest Leasure** – I am a BHS parent and a local contractor. I have done construction for 30 years and I have been alarmed by the conditions at BHS. I was encouraged to hear there was some study and reporting being done. However, what was not in the report was that certain buildings are not being replaced and structural issues are not being addressed. I heard there was a proposal to include those structural conditions. I have seen the issues in the cafeteria and the old gym. In my professional opinion, both of those structures are on the edge of being condemned. They are not safe. I do not feel comfortable with my child in that building as it is. I would encourage you all to go and inspect those parts of the building that are on the verge of collapse. It is unacceptable that it got into this condition and unacceptable that last week multiple people on the board were saying how good things were when the report appraises the structures as "fair." I would like you to take seriously what Mr. Putnam and Gabi reported to you last week regarding those structural conditions.

**Claudia Hawkins** – It was so impressive to hear the students speak, not only what they said but how they said it. It shows that we have good teachers in the schools and the parents that are mentoring them. I would like to talk about the operating budget for the next fiscal year. If the newspaper report is accurate, I agree with Mr. Weiner's suggested approach regarding PreK. Let's not just walk away because of a difficulty in finding space and staffing and come up with a comprehensive plan for what it would take to meet the need for PreK in Transylvania County. It seems to be our go to response when challenges in this county require money to respond with a defeatist attitude. PreK is a critical need in this county for the development of our children and to ease the critical need for childcare. Let's have a plan that the public can get behind even if it means a tax increase. I was also disappointed that the board of education did not hold a more comprehensive public work session for the operating budget. It may have been part of the meeting that I wasn't able to access. A public work session with more detail and discussion about the proposed local funding budget would have been helpful. You missed an opportunity to explain to the public your funding priorities and to explain the choices you are making and why you are making them. Like it or not, when you as the board do not hold the purse strings for local funding, you have to sell the proposed budget. Your goals should be to make it easy for the commissioners to say yes, even if it means a tax increase, because the public understands and is on board.

**Diane Nelson** – I am PFES parent. I am speaking on behalf of parents on the PreK wait list to say what an amazing job Ms. Collins and other PreK staff are doing. (Gave examples of things her child is learning). These are 4-, 5-, and sometimes 3-year olds. This is a critical point in their

brain development. I encourage you to think about the really long ark of education and how investing in PreK will trickle up into elementary, middle and high school. Please do not cut PreK on behalf of all the parents on the wait list.

**Ashley Dixon** – I am a 27-year teacher. I want to say thank you to a group of people who fall into the category of "teaching everyone takes everyone" and that is our school bus drivers. As a kid, I walked to school and was so jealous of all my friends who got to ride the buses and be dropped off at their front door. Bus drivers then and still are my heroes. They begin before the sun rises. They are the first and last faces that our students see as part of their school day. They are our first line defense when something is not quite right in a child's home. Every year, I get to sign up to ride a route. We all do. I always try to sign up first and get the longest route, because this is my time to ride a school bus. I love it. Thank you to all of these amazing men and women who drive our buses.

**Jenni Axtell** – I want to speak on behalf of students. Every parent has the right to decide what is best for their child. I started in the classroom and then spent 23 years in the media center, so I know books. This year I am teaching 8<sup>th</sup> grade science at BMS. Parents have trained their children in what is right for them. What a parent decides is right for their house should not take away from what is right for another parent's house. Since we are public schools, we serve everyone. Everyone. There have been books in my libraries that I personally had no interest in reading. But that same book may have been the thing that got a student interested in reading. My role is to get information to the students and make sure they have access to information that is appropriate for them. I encourage you as the board to take into account firsthand information.

**Steven Keate** – Congratulations to the board, Superintendent Fletcher and her staff for working with the consultants and county commissioners to bring the Phase 1 bond project list forward for our school system. Working collaboratively, it appears to present a win-win environment for the schools and the taxpayers. Here are my recommendations. Please insure that each major project is assigned scheduled milestones and budgets. Provide full transparency for the public by adding a section to the TCS website with costs, budget updates, etc.

**David Trowbridge** – I met with Dr. Fletcher recently to discuss the proposed wrestling facility listed on the Phase I project list. I also met with the coaches at Robbinsville High. After they built their wrestling facility, their participation increased greatly and they have won a number of championships. I noted in the materials for tonight's meeting that the line item for the wrestling facility now says remove altogether. That does not make sense. I understand we are trying to get grant funding for this, but Transylvania has been denied on two prior attempts. There seems to be a very small chance of getting it. It is a longshot. It the grant were to be successful, the wrestling team could move over to the replacement gym and free up the current space for other activities. I would request that you do not remove the wrestling facility that was already approved by the county commissioners. Let's please proceed with the design as this facility is just 1% of the proposed bond budget. We can continue researching other schools and also design it to comply with Title IX and other federal requirements for girls' sports.

**Scott Russell** – I am here to support the wrestling team and facility. My son and daughter wrestle. Wrestling is really important to our family. It has driven me to be a better person. It has increased in popularity. Keep the wrestling facility on the Phase 1 plan. Do not push it out to a later date and depend on a state grant that may or may not happen. We used to have a small portion of the football fieldhouse. We always had to wait for the football season to be over. That pushes back the time available for wrestling practice. Please consider keeping the wrestling facility. It can be used for multiple other sports and clubs. Let's get it done sooner rather than later.

# 5. <u>Phase 1 Bond Projects</u>

The board reviewed a revised list of projects to be included in Phase 1 bond funding. Dr. Fletcher reported that both board chairs, vice chairs, Gabi Juba, Kerry Putnam, Jaime Laughter, and she had met earlier in the day to review the list and any concerns. The only change was the addition of the BHS cafeteria which was left off the county's original list. Mr. Putnam noted that there is ongoing discussion as to whether an engineer is needed for the BHS cafeteria and gym repairs. Ms. Juba reported that a work scope team is being formed for the bond projects. The county is on the Local Government Commission's agenda for October. It will likely be November before any bond funds are available. Until then, it may be possible to use capital funds or lottery funds to move forward on some projects. The first tranche of bond money would only be for things on this list. Any new construction would have to wait for the second tranche of money. Dr. Fletcher reported that a grant may be written for the wrestling facility. There were a number of questions from board members. The board recommended that Dr. Fletcher, Kerry Putnam, and Gabi Juba serve on the scope of work team. ON A MOTION BY MR. MR. WIENER, SECONDED BY MR. O'NEILL, the board voted unanimously to approve to the Phase 1 projects plan as presented.

# 6. <u>Budget</u>

Finance Officer Gabi Juba presented the proposed FY25 budget request for review and approval. The county manager has requested the board of education's budget request by April 20. The Fund 2 local request includes the following:

- Cover 3% local salary increase for locally paid staff to match state mandates
- Funding to support mandated benefit rate changes
- Funding support for impact of increase to teachers, assistant principals, and principals. Top three combined \$529,910
- Funding for two counselor positions currently funded by ESSER \$165,163
- Funding for three additional counselors \$247,745.85
- Funding for dropout prevention specialist currently funded by ESSER \$90,878
- Miscellaneous increases (utilities, SROs, school nurses, copier costs, insurance, legal, etc.) \$500,000
- Additional three PreK classrooms deficit to serve all children for next year \$319,490.07
- Keeping two PreK classrooms previously worked up to make budget balance \$270,000
- Increase to charter school payments based on increase in local funding \$361,577

Mr. Juba reported the board would need an additional \$2 million in local funds over last year in order to pay for everything being requested. The capital request totals \$4,053,098 per the bond project spreadsheet.

Mrs. Dalton questioned why the board would ask for funding for three additional PreK classrooms when there is no place to put them? Dr. Fletcher noted that the harder part might be finding enough qualified teachers and teacher assistants to staff them due to strict guidelines on PreK certification standards and teacher:student ratios. There was considerable discussion regarding the feasibility of adding PreK classrooms. MR. WIENER MOVED to approve the budget request for 2024-2025 as presented. MR. O'NEILL SECONDED. Additional discussion followed. Mr. Wiener called the question. ON A ROLL CALL VOTE, the motion passed 3:2 (FOR: Wiener, O'Neill, Jackson; AGAINST: Dalton, McCoy). Dr. Fletcher stated that she will prepare to present the FY25 budget request to the Board of Commissioners at their meeting on April 8.

# 7. <u>Central Services Summer Schedule 2024</u>

Dr. Lisa Fletcher presented the 2024 summer schedule for central services and other administrative offices as information. Nine 40-hour weeks consisting of four 10-hour days will begin on Monday, June 17 and end on Thursday, August 15. Offices will be open 7:00 a.m. to 5:00 p.m. Monday through Thursday. Offices will be closed on Fridays and on Thursday, July 4, for the Independence Day holiday. The regular five-day schedule will resume on Monday, August 19.
