The Transylvania County Board of Education met in regular session on Monday, March 21, 2022 at 6:30 p.m. at the Morris Education Center. Marty Griffin led in a moment of silence and Courtney Domokur led the Pledge of Allegiance. Chairman McCoy called the meeting to order and welcomed everyone. In addition to approximately nine guests, the individuals listed below were in attendance.

1. Approval of Agenda

ON A MOTION BY MRS. DOMOKUR, SECONDED BY MR. GRIFFIN, the meeting agenda for March 21, 2022 was unanimously approved as presented.

2. Public Comment

Chairman McCoy reviewed the guidelines for public comment and informed speakers that they would have three minutes each.

Mickey Robinson gave an update on the Isaac Homes Youth Shelter, a support center for homeless and at-risk youth in the community. Mr. Robinson has been raising funds for the past two years to build the shelter and has a potential site in Rosman. He would

like to establish a shelter in Brevard as well. Mr. Robinson reported that he has procured a grant from Land of Sky for laptops and internet service, and other grants are pending. The center will provide clothing and supplies and overnight accommodations if needed.

Ryan Hinkleman gave an update on Rosman Youth Support Center, a subsidiary of Isaac Homes. The Center would provide meals, take-home food, clothing, and educational support for at-risk and homeless youth. He would like to explore partnering with the school system to provide school bus service to the center and other supports if possible.

Chairman McCoy thanked Mr. Robinson and Mr. Hinkleman for their efforts on behalf of at-risk youth and expressed hope that the school system can help with these worthy endeavors. Mr. Jackson noted that the Brevard Rotary Club is helping to support the projects as well.

3. Good News Report

Dr. McDaris recognized the student artwork from Brevard High School that was on display in the board room and thanked School Resource Officer Kelly Cook for attending the meeting. He presented the following items.

All of our schools will be showcasing projects, and we can't thank the teachers enough for their work in preparing for this event. Thanks also to our community partners that will be joining—Transylvania Parks and Recreation, Holmes Educational State Forest, and Mountain Roots Day Camp.

4. Former Students in the Military

The board recognized the list of former students from Brevard High School, Rosman High School, and Davidson River School who are currently serving or have previously served in the U.S. Military. There were no new names on the list.

5. Consent Agenda

ON A MOTION BY MR. GRIFFIN, SECONDED BY MR. JACKSON, the minutes of the February 16 and February 21, 2022 meetings and the personnel report for March 21, 2022 (attached) were unanimously approved.

6. Annual Financial Report 2020-2021

Mr. Terry Andersen of Carland & Andersen, Inc., Certified Public Accountants, presented the Transylvania County Schools Annual Financial Report for the fiscal year July 1, 2020 through June 30, 2021. He reviewed the financial statements and reported there were no findings or contested costs; internal controls are working effectively; and there is good fiscal stewardship in all areas. Mr. Andersen noted some suggestions for improvement in the School Nutrition accounting procedures, which is common in all school systems. Chairman McCoy thanked Mr. Andersen for his presentation and expressed the board's appreciation to the finance staff and school bookkeepers for their excellent work.

7. COVID-19 Update and Review of Mask Policy

Dr. Brian Weaver reported that the rate of COVID infections has slowed drastically over the last several weeks. As of today our schools had zero students and zero staff absent due to COVID cases or quarantine. All North Carolina counties are in low transmission, and all North Carolina school systems except for three are now mask-optional. Mr. Kiviniemi reported that current guidance from the NC Department of Health and Human Services is that schools may go optional. ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. GRIFFIN, the board unanimously affirmed the current mask-optional policy for another month until the next monthly review.

Mr. Griffin asked for an update on substitute teachers and bus drivers. Dr. Weaver reported that we still need substitutes and reliable bus drivers. Unexpected absences are difficult to fill.

8. FY23 Budget Update

Finance Officer Gabi Frost presented a budget amendment for Fund 2. The amendment reflects actual expenditures. ON A MOTION BY MR. KIVINIEMI, SECONDED BY MRS. DOMOKUR, the budget amendment for the Local Current Expense Fund was unanimously approved (see attached). Ms. Frost gave an update on I expenditures to date in Funds 1-8. She reported that 55% of the total budget has been spent so far.

Mrs. Frost reported that the General Assembly has created a recurring appropriation to fund a supplement for teachers and certified instructional support staff from the Supplemental Fund for Teacher Compensation (PRC 071). Board approval is required for the local distribution plan. Each eligible person will receive \$930 before taxes and retirement. The supplement will be paid in April 2022. Ms. Frost reported that the state based the allotments on property tax value per county. The supplement amount in future years will be determined by state allotment and legislature. ON A MOTION BY MR. KIVINIEMI, SECONDED BY MR. JACKSON, the Supplemental Funds for Teacher Compensation (PRC 071) distribution plan for April 2022 was unanimously approved.

Ms. Frost reviewed preliminary Fund 2 budget changes for FY23. Mr. Kiviniemi recommended resubmitting a request to increase the teacher supplement and Mr. Griffin agreed. Chairman McCoy recommended removing items with zero amounts from the list. Dr. McDaris gave an update on athletic event security. Mr. Kiviniemi requested adding back restoration of the instructional supplies cut. Mr. Griffin asked about School Resource Officer (SRO) funding. Dr. McDaris explained that the school system receives some state funding for SRO salaries; the rest is paid from local funds. The county pays the school system for the local portion; the school system must turn around and pay that back to the county; then the county pays the sheriff's department. This enables the county to show SRO funding as part of its local contribution to the schools, but it is basically a wash. Board members expressed thanks and appreciation to the sheriff's department for their strong partnership with the school system during the last 20 years of an outstanding SRO program. Our SROs have helped build trust in law enforcement and a strong relationship with our communities. Dr. McDaris noted that not all counties are as fortunate to have this type of relationship.

Mr. Jackson asked about the travel line items in the budget that have stayed the same for four years, calling it suspicious. Mr. Kiviniemi explained that increasing the travel allotments would necessitate asking for additional money from the commissioners. He reported that the principals keep up with how much is spent from their schools' travel accounts. Chairman McCoy added that the numbers have stayed the same because the board has not requested an increase for travel due to more pressing priorities. Mr. Jackson suggested taking money away from some schools and giving more to others. Chairman McCoy gave a reminder that the budget request for FY23 is due to the commissioners by May 15th.

9. Bond Update

Dr. McDaris reported that the Board of Education and the Board of Commissioners met jointly on January 31, 2022 to discuss the school bond projects. The commissioners have asked additional questions and the board has submitted responses from the architects and the board attorney. The board awaits a response.

10. Superintendent's Update

Dr. McDaris reported that our region, as part of the Asheville metro, continues to have the second lowest unemployment rate (2.6%) of any NC metro. While that may sound good, it also highlights a challenge for our region. Nathan Ramsey, Director of the Mountain Area Workforce Development Board, reports that, "Most people that lost their job during the pandemic have gone back to work. Our greatest challenge is we still haven't recovered the jobs that we lost prior to the pandemic, and our labor force is smaller by almost 10,000 individuals." There are simply far more jobs than people in our region. Ramsey reports that on any given day there are about 20,000 jobs open in this area. We also have issues with underemployment and wages. That relates to the county Tier designations. County Tiers are calculated using four factors:

- a. Average unemployment rate for the most recent 12 months for which data are available (October 2020 September 2021, NC Dept. of Commerce, LAUS)
- b. Median household income for the most recent 12 months for which data are available (2019, U.S. Census, Small Area Income & Poverty Estimates)
- c. Percentage growth in population for the most recent 36 months for which data are available (July 2017 July 2020, NC Office of State Budget & Management)
- d. Adjusted property tax base per capita for the most recent taxable year (FY2021-22, NC Dept. of Public Instruction)

The problem with this formula is that it is misleading and does not take into consideration other factors of importance. Consider a comparison of our county to Buncombe County, considered to be the economic hub of the region. Using the latest data that we have available from MyFutureNC, we see that:

- Transylvania County has a higher rate of children living in poverty than Buncombe (and higher than the state average).
- Transylvania County has a much lower median earnings per worker than Buncombe.
- Transylvania County workers earn much less in average weekly wages than workers in Buncombe County.
- However, using the Tier formula, Transylvania County has a median household income higher than Buncombe. It is worth noting that the median age in Buncombe is 42. For our county it is 51.
- Manufacturing provides some of the higher wages for workers, and also contributes heavily in local property taxes. In terms of those wages, the average weekly wage comparison between the two counties reveals that manufacturing jobs here earn much less than Buncombe. Buncombe has a higher percentage of their worker population employed in manufacturing than Transylvania.
- This suggests several things:
 - We know there is a worker shortage.
 - o We have less available affordable housing (including rentals) here.
 - o More of our population is either retired or about to be.
 - The wages that are paid are lower than a competing county.
 - The average weekly wage in arts, entertainment, and recreation in Transylvania County is about \$649.
 - The average weekly wage in manufacturing in Buncombe County is about \$1.039.
- Not only are we at risk of not having enough workers in our county, we could lose more of the ones we have. That will not be a pretty sight in terms of what residents here will have to pay for services. We are already higher in many respects. We need the type of industries that pay higher wages.
- Transvlvania County Schools are doing some strong work in preparing students for the future. The 2021 graduation rates for Brevard High School and Rosman High School are both above the state average. BHS was 88.8% last year and RHS was 95%. Our alternative program at Davidson River School is doing great work with students who might otherwise be dropouts and have raised their graduation rate 20% since 2016. This is impressive since the percentage of DRS students who are considered economically disadvantaged is 31 points higher than the state average.

12. Other Items

Mr. Griffin reported asked about a report that some school boards are ignoring state calendar legislation and setting their districts' start dates as they think best. Dr. McDaris reported that he had an opportunity to talk with the Cleveland County superintendent about this. In general, the superintendent had recommended a school calendar that was in line with the law. The board decided not to accept that calendar and voted in their own. A similar action took place in Rutherford County. DPI recently issued a notice reminding all NC districts of the current calendar law. Mr. Kiviniemi stated that he thinks choosing which state law laws to obey and which ones to not obey is heading down a dangerous path. He believes that board members are obligated to follow state law per their oaths of office, and as much as he would like for boards to have more local control, this is not the way to go. Mrs. Domokur added that the board would not want to risk retribution or jeopardize our system's position in the state.

Mr. Kiviniemi recommended that the board place the monthly COVID update and mask vote on the consent agenda from now on unless the situation changes. There was a consensus agreement to do so.

Mr. Jackson asked if the board could have more information on the Blue Zones Project in the schools. Dr. McDaris reported that a presentation is being readied for an upcoming meeting.

Mr. Jackson recommended that the board have another sit-down with the architect regarding construction/renovation plans because he thinks there are more questions to answer. Mr. Kiviniemi stated that the board is at a critical point to move forward with the bond projects. He stated that the county commissioners still have still not approved the contracts they were given on January 31, and if the contracts are not approved by April 4, we will not be able to break ground as planned.

13. Closed Session

ON A MOTION BY MRS. MCCOY, SECONDED BY MR. GRIFFIN, the board voted unanimously to go into closed session pursuant to N.C.G.S. § 143-318.11 for the following purpose(s): under subsection (a)(3) to consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege between the attorney and the public body. Following a short recess, the closed session convened at approximately 8:00 p.m. The following members were present: Tawny McCoy, Chair; Ron Kiviniemi, Vice Chair; Courtney Domokur, Marty Griffin, and Kimsey Jackson. Also present was Dr. Jeff McDaris, Superintendent; and Kris Caudle, Board Attorney. No action was taken in the closed session. At approximately 8:27 p.m. a motion to adjourn closed session and return to open session was made by Mr. Kiviniemi and seconded by Mr. Griffin. The motion passed unanimously.

There was no further business, and ON A MOTION KIVINIEMI, the meeting was adjourned at 8:28 p.n
