## 1. Approval of Agenda

ON A MOTION BY MR. GRIFFIN, SECONDED BY MRS. WELLBORN, the meeting agenda for May 7, 2018 was approved as presented.

## 2. Public Comment

John Wayne Hardison Jr. reported that he had served on the interview team the last time a principal was hired at Brevard Elementary School, and he was concerned that parents and faculty members were not involved in the hiring process this time around.

Stuart Dodson, OPT President at BES, reported that stakeholders were concerned at not being given an opportunity to be involved in selecting a new principal. He reported that people are nervous and worried that the transition might upset the current culture and climate at Brevard Elementary. He encouraged the administration to involve parents more and increase communication.

May 1<sup>st</sup> is recognized annually as National School Principals' Day, a time to honor the hard work and leadership of school principals everywhere. #### HOLOCAUST INTERVIEW

As part of their junior research project for Mrs. Dotson's English classes, RHS students Savanna Cook, Emma Galloway, Donovan Carr, Canon Clayton, Levi Galloway, Zach Goldsmith, and Braedon Welyczko had the opportunity to interview Mrs. Kay Kadden, a 98-year old resident at College Walk. The students, along with Dr. Marshall, Coach Ramey, and Mrs. Powell, heard Mrs. Kadden tell the history of her family and the Holocaust. In 1937, at the age of 17, Mrs. Kadden was able to come to America due to sponsorship by a family member in New York. She tells of her father escaping from Nazi concentration camps, her cousins' experience during The Night of Broken Glass, and of her personal return to her family home in Germany after the war.

#### TASTE OF TRANSYLVANIA SUCCESS

Many thanks to the TCS Educational Foundation for all their efforts, especially their recent fundraiser on May 1, the Seventh Annual *Taste of Transylvania*. With over a dozen restaurants donating appetizers, entrées, and desserts, TCSEF was able to raise approximately \$24,000 thanks to nearly 250 people in attendance. That number included 47 staff tickets, 24 of which were grant recipients who came to discuss their projects with attendees. ## STATE SUPERINTENDENT VISITS BES

On April 24, State Superintendent of Schools Mark Johnson visited Brevard Elementary School and got a firsthand look at all the wonderful things happening there. School and central office administrators were on hand to conduct a tour and answer questions.

Dr. McDaris recognized the artwork from Rosman High School that was on display in the board room and thanked Officer Stroup for being in attendance.

# 4. Former Students in the Military

The board reviewed the list of former students from Brevard High School, Rosman High School, and Davidson River School who are currently serving or have previously served in the U.S. Military. There were no new names on the list.

# 5. <u>Consent Agenda</u>

ON A MOTION BY MR. GRIFFIN, SECONDED BY MR. KIVINIEMI, the minutes of the April 16, 2018 meeting and the personnel report for May 7, 2018 (attached) were unanimously approved. Chairman McCoy announced that RES Principal Scott Strickler will be the new principal at Rosman Middle School, and BHS Assistant Principal Carrie Norris will be the new principal at Brevard Elementary School, effective July 1, 2018. Mr. Strickler replaces Greg Carter, who is retiring, and Mrs. Norris replaces April Gaydosh,

who is moving out of state. The board congratulated Mr. Strickler and Mrs. Norris on their appointments and thanked everyone present for their interest.

# 6. Federal Grants: Notice of Intent to Apply

Dr. Jeremy Gibbs reported that Transylvania County Schools has given public notice of the following applications for federal grants that have been or will be submitted within the next 30 days:

Dr. Gibbs gave an overview of federal programs and funding. He reported that 89% of Title I funds go toward salaries and benefits in the four elementary schools. Over the last five years, federal funding for our district has decreased by approximately \$776,000 due to budget cuts. Dr. Gibbs also reviewed the various methods employed to support Title I parent and family engagement in the schools.

# 7. Federal Programs Consolidated Cross-Program Monitoring Report

On March 15, the Department of Public Instruction's Federal Program Monitoring and Support Division conducted a cross-program consolidated monitoring review of the Transylvania County Schools federal programs. Dr. Jeremy Gibbs reported that Transylvania received a very positive evaluation, with zero findings, and 100% success in meeting all statutory compliance requirements in the review. During the review the monitoring team visited all four elementary schools, conducted classroom walkthroughs, reviewed documents, and interviewed parents, teachers, principals, instructional coaches, and central office administrators. The team had only four recommendations: (1) continue to build on parent engagement and refine the "parent compact" document; (2) build additional capacity for parent engagement for English Learner (EL) families; (3) share English Language Development standards with and build additional capacity in regular classroom teachers to support more EL students; and (4) provide professional development for teachers and staff to support increasing number of EL students. Board members commended Dr. Gibbs and everyone involved for a great report and effective and efficient stewardship of federal resources.

# 8. FY19 Budget

Norris Barger reviewed the FY19 budget request. He reported that the amount of increase in employer contribution rates for health insurance and retirement is still not definite as the state has not completed its budget. The COLA is also just a "best guess" at this time. The total increase in requested local appropriation is \$730,631, which is a 6.3% increase over last year. Mr. Barger noted that the list of changes includes no additional programs or "wish list" items, and no change in the teacher supplement rate. Most increases are due to external factors and mandates.

On the capital needs list, Mr. Barger reported that a column for priority rankings has been added per a request from the county manager. Recurring items were not prioritized. Board members discussed the changes and specific projects. Chairman McCoy recommended adding a section for total recurring items and total prioritized items. Mr.

Barger noted that none of the projects listed on the capital needs list would be impacted (i.e., torn down, redone, or painted over) if the bond is approved. If the bond does not pass, some critical projects will have to be done with lottery funds as funds permit. Board members discussed that they see some of the same items year after year because the yearly capital appropriation is never enough to take care of everything. MR. KIVINIEMI MADE A MOTION, SECONDED BY MRS. WELLBORN, to approve the budget request for the 2018-2019 fiscal year (with the proposed change to the capital outlay document as requested by Chairman McCoy) as presented. Chairman McCoy read a statement in support of the budget request from Mrs. McGaha, who was out of town with family. There was no further discussion, and THE MOTION CARRIED UNANIMOUSLY.

Dr. McDaris gave an update on a request to the county manager to discuss the local funding formula. Chairman McCoy remarked that she would be unable to attend a daytime meeting and would request an evening meeting. Mr. Kiviniemi stated that the funding formula was originally agreed to on a two-year trial basis, after which it would be revisited by both boards. He stated that the formula as written now has resulted in lost ground for the school system, making it no longer possible to even tread water.

# 9. Bond Update

Dr. McDaris reported that two community stakeholder sessions on the bond projects have been scheduled in conjunction with upcoming school board meetings. The first session will be held on Monday, June 4, at 6:00 p.m. in the media center at Brevard High School. The second session will be Monday, June 18, at 6:00 p.m. in the Rosman High School media center. Architects from Clark-Nexsen will be present to share information and answer questions. Norris Barger reported that the recent meetings with architects and school staffs at RMS/RMS and BHS have provided a great deal of positive feedback. Surveying is nearly completed. There is also interest in a field trip to tour an innovative high school in another district.

# 10. NCSBA 2018 Legislative Committee

Dr. McDaris reported that the North Carolina School Boards Association Board of Directors is accepting applications to serve on its Legislative Committee for 2018. Nominees must be able to commit to attending both of the committee's two scheduled meetings on August 27 and October 8 in Raleigh. The deadline for applications is June 15. ON A MOTION BY MR. KIVINIEMI, SECONDED BY MRS. MCCOY, the board unanimously nominated Marty Griffin to submit an application to serve on the Legislative Committee. Mr. Griffin accepted the nomination.

## 11. Superintendent's Update

Dr. McDaris presented data from "A Roadmap of Need," a whole child needs assessment for North Carolina youth by the Public School Forum. It includes multiple indicators of wellness across four domains: health, youth behavior and safety, education, and economic development. Dr. McDaris gave a look at how Transylvania County ranks in comparison with the state and peer counties:

Dr. McDaris reviewed the escalation of unfunded mandates and the impact on local budgets. Over the past ten years, the mandatory employer retirement contribution has increased 126.5% and the health insurance contribution has increased by 45.4%. He reported that most of the increase in the FY19 Local Current Expense budget request is due to external actions and factors.
