---- Reception -----

The Transylvania County Board of Education met in regular session at 4:30 p.m. on June 15, 2009 in the Rogow Room at the Transylvania County Library. Present were Mike Rogers, Chairman; Chris Whitmire, Vice Chairman; Tawny McCoy; Shelia Norman; and Cindy Petit. Also present were Dr. Sonna Lyda, Superintendent; Jenny Hunter, Administrative Assistant; and approximately 11 staff members, guests, and media. (Approximately 80 guests joined the meeting later for the retirees' recognition). Mr. Rogers gave the invocation and Mrs. Petit led the Pledge of Allegiance. Chairman Rogers welcomed everyone and called the meeting to order. He explained that the meeting had been scheduled two hours early in order for the Board members to attend the County Commissioners' budget meeting later that evening.

1. Public Comment

There was no public comment.

2. Good News Report

Dr. Lyda reported the following good news item:

Several world language students from Rosman High School attained national recognition for excellent performance on the 2009 National Spanish Examinations. The exams, sponsored by the American Association of Teachers of Spanish and Portuguese, are administered across the United States each year in grades 6-12. Six of the 15 students who took the exam earned honorable mentions. "Attaining a medal or honorable mention for any student on the National Spanish Examinations is very prestigious," said Kevin Cessna-Buscemi, National Director of the Exams. "The exams are the largest of their kind in the United States with well over 115,000 students participating in 2009." Students earning recognition were Leanna Hall, Amanda Huggins, Juan Mundo-Mendez, Brandon Newman, Chelsie Owen, and Crystal Owen. Their Spanish teachers were Julie Queen and Linda Carrillo.

3. Former Students in the Military

The Board reviewed the list of former students who are currently serving or have served in the U.S. Military. Chairman Rogers expressed the Board's appreciation to all of the individuals and their families for their dedication and sacrifice. The list will be updated as more names are received.

4. Consent Agenda

ON A MOTION BY MRS. NORMAN, SECONDED BY MRS. MCCOY, the Board approved the minutes from the May 26, 2009 and June 1, 2009 meetings and the personnel report for June 15, 2009 (attached).

5. Facilities Master Plan

Architect Mike Cox from Architectural Design Studio presented a first look at the new Transylvania County Schools Facilities Master Plan. The master plan includes recommendations for each school campus plus a possible new Education Center facility on the BMS campus. Board members will receive copies of the full plan at the next meeting, and the plan will be reviewed on a school-by-school basis over the course of subsequent meetings. In addition to site-specific recommendations, the plan includes renovations to provide more secure front entrances and better door security at all schools. Board members thanked Mr. Cox for his presentation and stated that they look forward to reviewing the plan in depth.

6. BHS "No Trespassing" Request

At the May 18 meeting, the Board heard a request from BHS Athletic Director, Mark Robinson, to post "no trespassing" signs on the Brevard High School campus in order to prevent the abuse of athletic fields, facilities and grounds by unauthorized users. The following language was proposed for the signs:

"No trespassing by order of the Transylvania County Board of Education. Trespassers will be prosecuted under N.C. General Statute 14-159.13."

The Board had requested time to consider the request and obtain feedback from the community. Mr. Rogers reported that the Board had received no concerns to date. Dr. Lyda, Doug Odom, and John Tinsley also reported no concerns. Mr. Robinson reported receiving one phone call regarding clarification. Mr. Robinson gave a reminder that law enforcement may not enforce trespassing violations without the appropriate signage. Dr. Lyda reported that the language above is the same as that used by the Henderson County Public Schools, who have reported that the signs work well for them.

Board members had concerns that the signs as written above would be too negative in tone. Mr. Whitmire discussed public perception and the importance of communication. He suggested the following alternative language for the signs:

"Use of these facilities implies consent to video monitoring. All individuals are reminded that pets are not allowed and that everyone will treat all facilities with respect. The football field and (list other areas) are not open for public use without written permission. Violators will be prosecuted."

Mr. Rogers stated that he liked the alternative language as a way of communicating the school's expectations to the public without damaging public relations and suggested trying the alternate signs as a first step. Then if the problem does not improve, the school administration could ask the Board to reconsider the original language. The

Board directed Mr. Tinsley to prepare a draft sign using the alternative language for the Board's consideration at the next regular meeting. Additionally, they requested that the sign include instructions for requesting permission to use the athletic fields/facilities, and that the signs be bilingual.

7. <u>Technology Purchase</u>

Donys Merrill presented a request to purchase 230 replacement desktops for Rosman Middle/High School for the 2009-2010 year. She explained that the current desktops are scheduled for replacement this year. Three bids were presented. Mrs. Merrill recommended that the Board accept the low bid from TiberCreek Consulting at this time in order to get the equipment ordered and installed before school starts in August. The current desktops will be relocated elsewhere in the district to expand and fill in where needed. ON A MOTION BY MR. WHITMIRE, SECONDED BY MRS. NORMAN, the Board approved the bid of \$155,908.38 from TiberCreek Consulting for the purchase of 230 replacement desktops for Rosman Middle/High School.

8. FY10 Interim Budget Resolution

Dr. Lyda reported that in order to pay salaries and operating expenses beginning July 1 until the adoption of the final budget resolution for the next school year, the Board must adopt an Interim Budget Resolution. ON A MOTION BY MRS. MCCOY, SECONDED BY MRS. NORMAN, the Interim Budget Resolution for 2009-2010 was approved:

BE IT RESOLVED BY THE TRANSYLVANIA COUNTY BOARD OF EDUCATION, that interim appropriations be made available for the purpose of paying salaries and the usual and customary expenses of the Transylvania County Schools for the period beginning July 1, 2009, until adoption of the 2009-2010 Budget Resolution. Interim appropriations so made and expended shall be charged to the proper appropriations in the Budget Resolution. Passed by majority vote of the Transylvania County Board of Education on the 15th day of June 2009.

9. FY09 Budget Amendments

 Includes e-rate revenue and workforce development grant. Overall increase \$84,062. MOTION BY MRS. MCCOY, SECONDED BY MR. WHITMIRE.
- Budget Amendment No. 1 for the Federal Grants Fund (attached). Includes carryover and transfers to cover required reversion. Overall increase \$77,073.

- Budget Amendment No. 1 for the Capital Outlay Fund (attached). Includes appropriated fund balance for purchase of activity bus budgeted in previous year,

BES piano purchase, and RES parking/play area. Overall increase \$70,068. MOTION BY MRS. MCCOY, SECONDED BY MRS. PETIT.
