A system of excellent schools prohibits illegal discrimination and harassment of staff and students, 1 2 encourages tolerance and respect, and seeks to eliminate or lessen other barriers that may impede 3 a student's ability or opportunity to learn, including economic disadvantages, poor nutrition, ill-4 health, and lack of transportation.
