

## GOALS AND OBJECTIVES OF THE EDUCATIONAL PROGRAM

Policy Code: 3000

1 The [Transylvania County Board of Education \(the “board”\)](#) believes that the function of formal  
2 education is to provide a foundation for lifelong learning and to enable each student to  
3 participate effectively and responsibly in a changing world. The board recognizes the critical  
4 role of parents, governmental and nonprofit agencies, businesses, and the community in helping  
5 individual students and the school system meet educational goals. To ensure that the educational  
6 program meets rigorous academic standards, the board shall strive to maintain accreditation of its  
7 schools by the Southern Association of Colleges and Schools and/or the State Board of  
8 Education.

9  
10 A successful educational program also depends on innovation at the individual school level. The  
11 board is committed to allowing administrators at individual schools to develop and implement  
12 plans necessary to ensure the educational success of their students.

14 In addition to providing a basic education program as prescribed by the State Board of  
15 Education, the board believes that the administrators of the educational program also must strive  
16 to provide each student with the opportunity to:

- 17  
18 1. learn to be responsible for and accept the consequences of his or her conduct and  
19 academic performance;
- 20  
21 2. develop the capacity to examine and solve problems;
- 22  
23 3. foster respect and appreciation for cultural and ideological diversity and differences;
- 24  
25 4. develop the ability to be productive in a team environment;
- 26  
27 5. learn and acquire the skills necessary for a lifetime of continuous learning and adaptation  
28 to change in the workplace and society;
- 29  
30 6. prepare for challenging curriculum beyond secondary school and, when appropriate,  
31 complete high school courses required for college entry in less than four years;
- 32  
33 7. achieve high levels of success in a rigorous curriculum;
- 34  
35 8. acquire the skills necessary for success as life-long learners;
- 36  
37 9. acquire the skills needed for technological literacy in a rapidly changing world; and

- 39 10. remain in school and earn a high school diploma and, when appropriate, earn additional  
40 college credit.
