

1 The Transylvania County Board of Education (the “board”) may enter into contracts with public
2 or private carriers in accordance with G.S. 115C-253, State Board of Education policy, any other
3 applicable law, and this policy. Any contracts also must comply with policy 6450, Purchase of
4 Services.
5

6 The superintendent or designee shall develop safety standards for contracted commercial bus
7 transportation services used to transport students to school-related activities. The standards must
8 comply with the requirements established by the State Board. The superintendent or designee
9 shall develop a list of companies or individuals that meet these standards and are approved to
10 provide student transportation services. If appropriate, the superintendent shall recommend that
11 the board enter into interlocal cooperation agreements to assist in developing the standards and
12 list of approved entities required under this paragraph.
13

14 The superintendent shall ensure that the school system contracts for student transportation
15 services only with companies or individuals who are on the approved list.
16

17 The board may purchase or lease student transportation vehicles in accordance with law and
18 board policy, including policy 6430, ~~State~~ Purchasing Requirements for Equipment, Materials,
19 and Supplies, ~~policy 6440, Local Purchasing Requirements for Equipment, Materials, and~~
20 ~~Supplies~~, and policy 6425, Continuing Contracts. Any such vehicle must meet federal safety
21 standards and state requirements.
22

23 All titles will be issued to the board of education. Sufficient liability coverage must be
24 maintained in accordance with policy 8340, Insurance.
25

26 The board will consider requests for providing transportation services to a charter school. Such
27 consideration will take into account any factors required by law.
