SCHOOL FINANCE OFFICER

A. SELECTION AND EVALUATION

The superintendent shall select and the Transylvania County Board of Education (the "board") will approve a school finance officer. The finance officer serves at the pleasure of the superintendent. The superintendent shall evaluate the finance officer to help ensure that all duties as required by law, board policy, and/or the superintendent are met.

B. DUTIES

The school finance officer provides critical services for the effective planning and use of fiscal resources. The school finance officer shall be responsible to the superintendent for:

- 131.keeping the accounts of the school system in accordance with generally accepted14principles of governmental accounting, board policy, the rules and regulations of15the State Board of Education, and the rules and regulations of the Local16Government Commission;
 - 2. giving the preaudit and disbursements certificates required by G.S. 115C-441(a1) and (d1), respectively, and establishing procedures to assure compliance with the preaudit requirements;
 - 3. approving or disapproving a disbursement, in accordance with G.S. 115C-441(b), when a bill, invoice, or other claim is presented and establishing procedures to assure compliance with all applicable legal requirements for disbursements;
 - 4. signing and issuing all checks, drafts, and state warrants by the school system;
 - 5. investing the cash balance of any funds, subject to board policy 8110, Budget Resolution;
 - 6. receiving and depositing all moneys accruing to the school system;
 - 7. preparing and filing a statement of the financial condition of the school system as often as requested by the superintendent;
 - 8. preparing and filing a statement of the financial condition of the school system when requested by the board of education or the board of county commissioners, but only if such requests are in writing and copied to the superintendent;
 - 9. providing a copy to the board and notice to the county commissioners of any report received from the Teachers' and State Employees' Retirement System containing a list of employees whose retirement in the upcoming year would likely result in an assessment to the board for additional employer contribution;

45 10. performing such other duties as may be assigned by law, by the superintendent, or 46 by rules and regulations of the State Board of Education and the Local 47 Government Commission; 48 49 submitting reports to the Secretary of the Local Government Commission as 11. 50 required by law; 51 52 12. receiving and accounting for all clear proceeds of fines, penalties, and forfeitures 53 and notifying the superintendent and board of such funds; 54 55 13. reviewing school improvement plans that provide for the transfer of funds 56 between funding allotments or lease purchase contracts; 57 58 14. evaluating all continuing contracts, including the principal and interest to be paid, 59 and making recommendations to the superintendent and reports to the 60 superintendent and board as provided in board policy 6425, Continuing Contracts; 61 62 15. assisting the superintendent in the development of the budget; 63 64 16. prescribing the form and detail of records maintained by the school treasurer; 65 66 17. making salary deductions as provided in policy 7620, Payroll Deductions; 67 68 18. maintaining custody of the facsimile signature device as provided in policy 8330, 69 Facsimile Signatures; and 70 71 19. maintaining custody of insurance policy and programs as provided in policy 8340, 72 Insurance. 73 74 C.
