Sex education lessons taught by a non-school employee or lesson(s) taught by a school employee 1 that are more extensive than the North Carolina Standard Course of Study shall require that a 2 letter be sent to the parent/guardian giving the date, time, objective(s), and description of the 3 lesson(s). This letter shall contain a permission form (IGB-E) with a place for the 4 parent/guardian to sign allowing their child to participate in the lesson(s). The permission form 5 will also provide a place for the parent/guardian to sign denying permission for their child to 6 7

participate in the lesson(s). Every child must return the permission form (either approved or

8 denied) and the teacher shall submit these forms to the principal.

Students who do not participate in the sex education lesson(s) shall be given another assignment at school. Students who fail to return the permission form will not be allowed to participate in the lesson(s).

The Transylvania County Board of Education is committed to a health education program that provides students with accurate information and encourages them to be responsible for their own health and behavior. The Board recognizes the primary role of parents in providing for the health and well-being of their children and seeks to involve parents as provided in this policy. The health education program provided by the school system will meet the requirements of the Basic Education Program (BEP), G.S. § 115C-81(e)(1), and aligned state-adopted standards (*The* Healthful Living Standard Course of Study). The Board may, at its discretion, expand on the subject areas to be included in the program and on the instructional objectives to be met.

## HEALTH AND SAFETY EDUCATION PROGRAM A.

A health and safety education program must be taught to students from kindergarten through ninth grade. As required by law, the health education program must include ageappropriate instruction on bicycle safety; nutrition; dental health; environmental health; family living; consumer health; disease control; growth and development; first aid and emergency care; mental and emotional health; drug and alcohol abuse prevention; prevention of sexually transmitted diseases (STDs), including HIV/AIDS and other communicable diseases; and reproductive health and safety education.

As required by law and beginning in seventh grade, reproductive health and safety education will include age-appropriate instruction on sexual abstinence until marriage. STDs, the human reproductive system, effective contraceptive methods for preventing pregnancy, and awareness of sexual assault and sexual abuse.

Each year before students participate in reproductive health and safety education or in other separate instruction on the prevention of STDs, including HIV/AIDS, or the avoidance of out-of-wedlock pregnancy, the principal or designee shall notify parents of the opportunity to review the materials and objectives that will be used in instruction. A copy of all objectives and materials will be available for review in the principal's office

59		For reproductive health and safety education, teachers shall follow the instructional
60		objectives and only use the age-appropriate materials that have been made available to
61		parents for review in accordance with this policy. Information conveyed during
62		instruction will be objective and based upon scientific research that is peer reviewed and
63		accepted by professionals and credentialed experts in the field of sexual health education.

65		A determination of what is an appropriate education for a student with disabilities must
66		be made in accordance with the student's individualized education plan, following all
67		procedures as provided in the North Carolina Policies Governing Services for Children
68		with Disabilities.
