## SCHOOL ADMISSIONS

Students entering public school kindergarten in Transylvania County shall be five years old on or
 before August 31 of that year. They must be presented for enrollment during the first 120 days
 of the school year. The initial point of entry shall be at the kindergarten level unless otherwise
 determined by the school principal/designee.

6 Students entering Transylvania County Schools shall meet all state and local requirements

pertaining to first-time enrollees or transfers. All students initially entering, transferring to, or
 receiving services on any campus in the Transylvania County School System shall, within 30
 calendar days of enrollment or the beginning of any service, submit the following items:

The principal shall have the authority to require the parents/guardians of any child 11 1. 12 presented for admission for the first time to furnish a certified copy of the birth certificate 13 of such child or other satisfactory evidence of date of birth. A certified copy of the 14 child's birth certificate, which shall be furnished by the register of deeds of the county 15 having on file the record of the birth of the child, or other satisfactory evidence of the 16 child's date of birth. School authorities may accept only competent and verifiable 17 evidence as secondary proof of age, specifically including but not limited to (1) a 18 certified copy of any medical record of the child's birth issued by the treating physician 19 or the hospital in which the child was born, or (2) a certified copy of a birth certificate 20 issued by a church, mosque, temple, or other religious institution that maintains birth 21 records of its members. 22

- 23 2. A current up-to-date copy of the student's immunization record.
- The Kindergarten Health Assessment Report when applicable. This Health Assessment
  Report must be completed within 12 months prior to the date of school entry.
- 28 4. A completed Home Language Survey.

All parents/guardians enrolling their child for the first time into Transylvania County Schools shall complete the Educational Residency Affidavit/Disciplinary Status Affidavit form. The parent/guardian of a student transferring within the county shall be required to fill out the Educational Residency Affidavit/Disciplinary Status Affidavit at their new school. Parents/ guardians refusing to complete this form may be subject to tuition/local funding fees. The section of this form dealing with suspension/expulsion is not required of a student who has never been enrolled in or attended another private or public school in this or any other state.
