

1 The Board is committed to the safety of students, school employees, and other persons on school  
2 property. In order to create and maintain a safe school environment and to comply with N. C.  
3 Gen. Stat. § 14-208.18, the Board establishes the following policy provisions:  
4

5 **A. STUDENT SEX OFFENDER ON SCHOOL PROPERTY**  
6

7 A student who is enrolled in the school system and is a registered sex offender is  
8 expressly prohibited from (1) knowingly being present on any property owned or  
9 operated by the school system, including school buildings, athletic fields, playgrounds,  
10 parking lots, buses, and other property, and (2) attending school-sponsored or school-  
11 related activities, except to the extent the student is permitted to be on school property to  
12 receive educational services. **For the purposes of this policy, the term “educational**  
13 **services” means solely classroom instruction.**  
14

15 A student who is a registered sex offender who is receiving educational services on  
16 school grounds must comply with the requirement that he or she be supervised by school  
17 personnel at all times.  
18

19 **B. EDUCATIONAL SERVICES FOR STUDENT SEX OFFENDERS**  
20

- 21 1. If permitted by the Board, a student who is subject to Section A of this policy and  
22 is eligible to attend public school under N. C. Gen. Stat. § 115C-378 may be  
23 present on school property subject to any conditions and restrictions imposed by  
24 the Board.  
25
- 26 2. The Board will hold a hearing to determine whether to expel the student or  
27 provide the student with educational services in accordance with subsection B.4.b.  
28 of policy JGDA, “Long-Term Suspension, 365-Day Suspension, and Expulsion.”  
29
- 30 3. Prior to expelling a student pursuant to N. C. Gen. Stat. § 115C-390.11(a)(2), the  
31 Board will consider whether there are alternative education services that may be  
32 offered to the student.  
33
- 34 4. If the Board determines that a student will be provided with educational services  
35 on school property, the student must be supervised by school personnel at all  
36 times.  
37
- 38 5. If a student subject to this policy violates the conditions and restrictions placed on  
39 the student by the Board, school officials will impose disciplinary consequences  
40 consistent with the terms of the conditions and restrictions placed on the student’s  
41 admission or as otherwise provided in Policy JFC, “Student Conduct/Discipline,”  
42 and any applicable provisions of the Code of Student Conduct.  
43

44           6. If a student subject to this policy is a student with disabilities, he or she will be  
45           provided with educational services in compliance with federal and state law.
