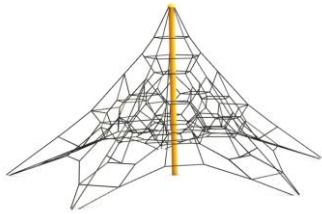

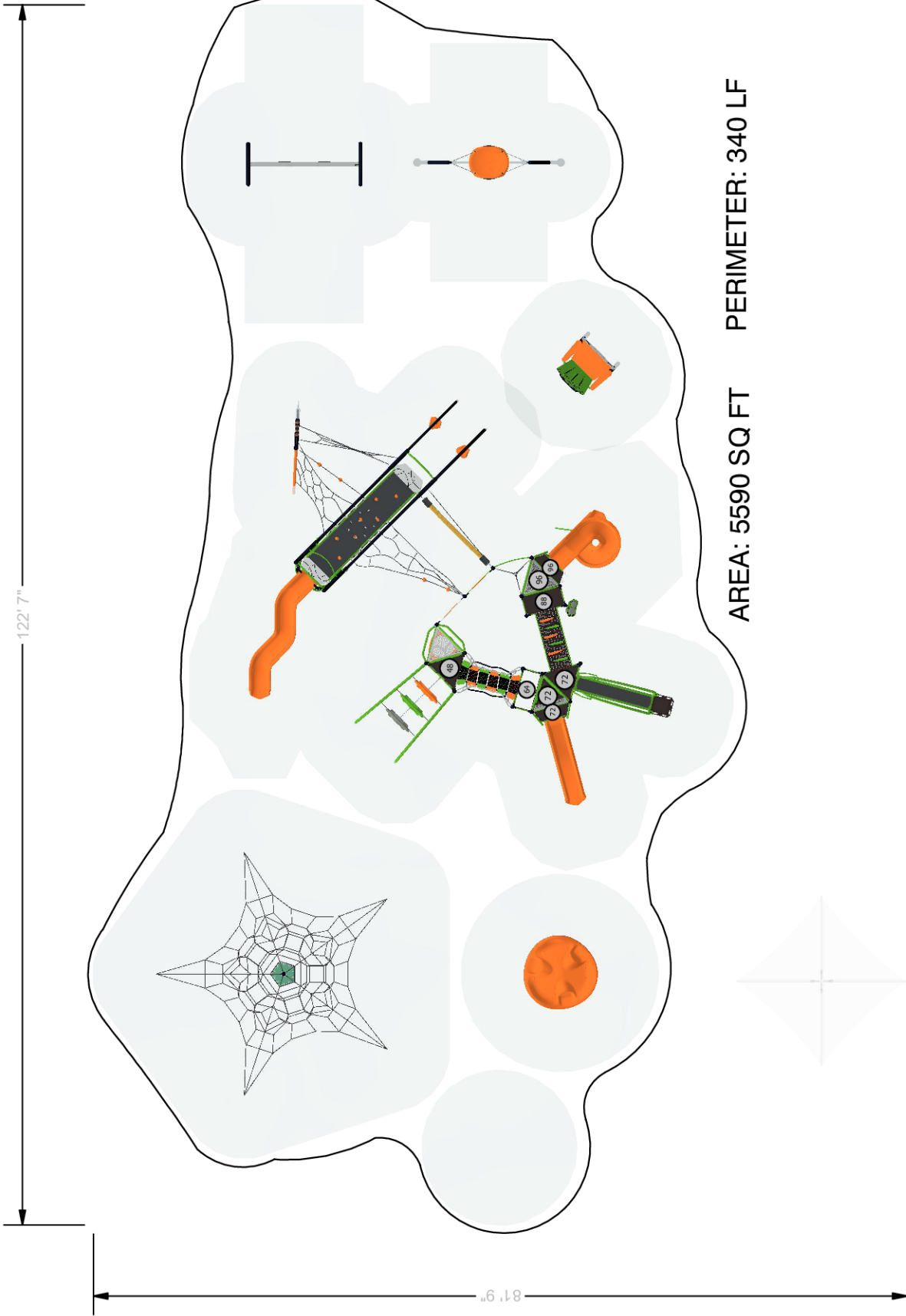

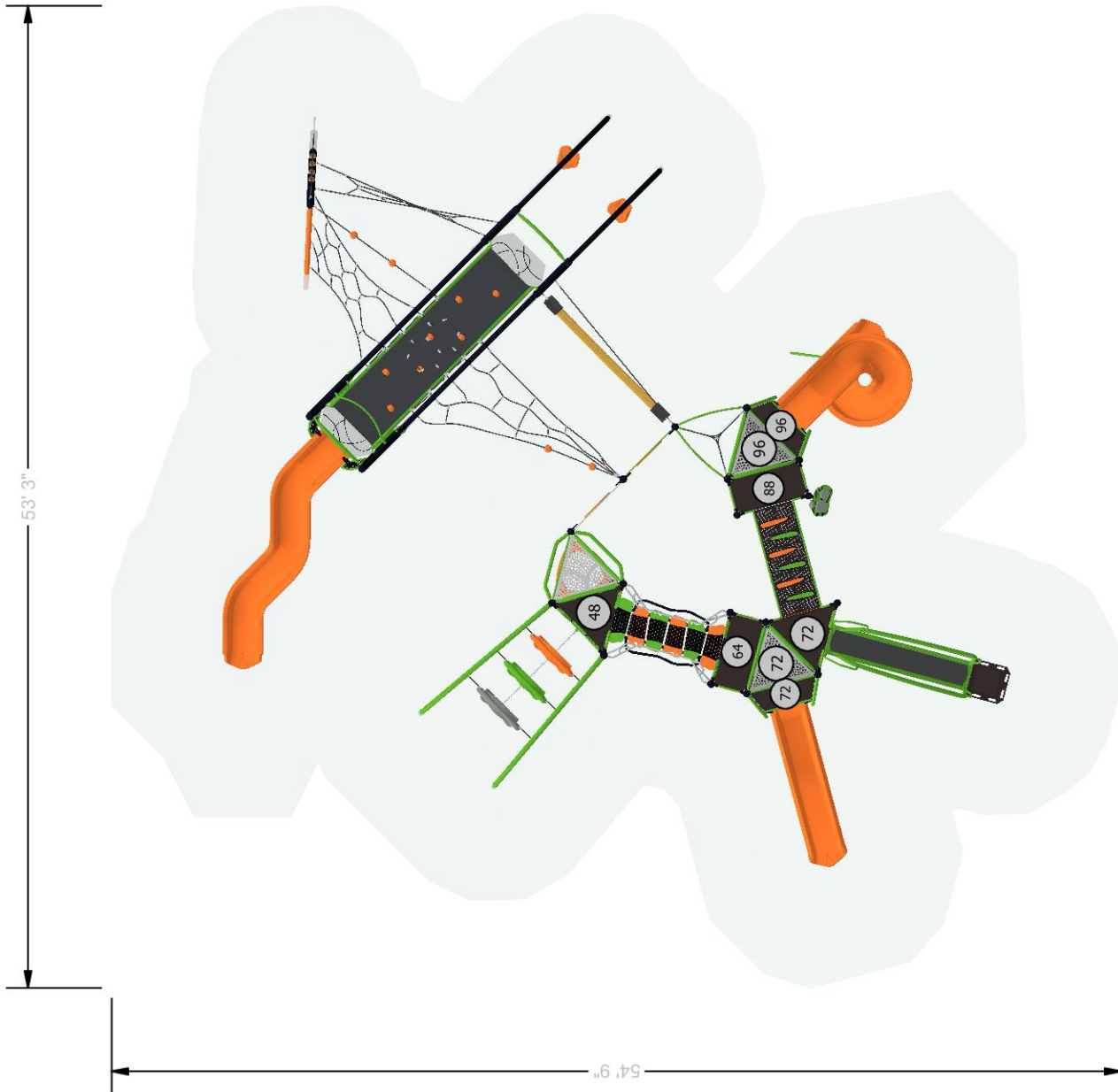


SITE PLAN VIEW

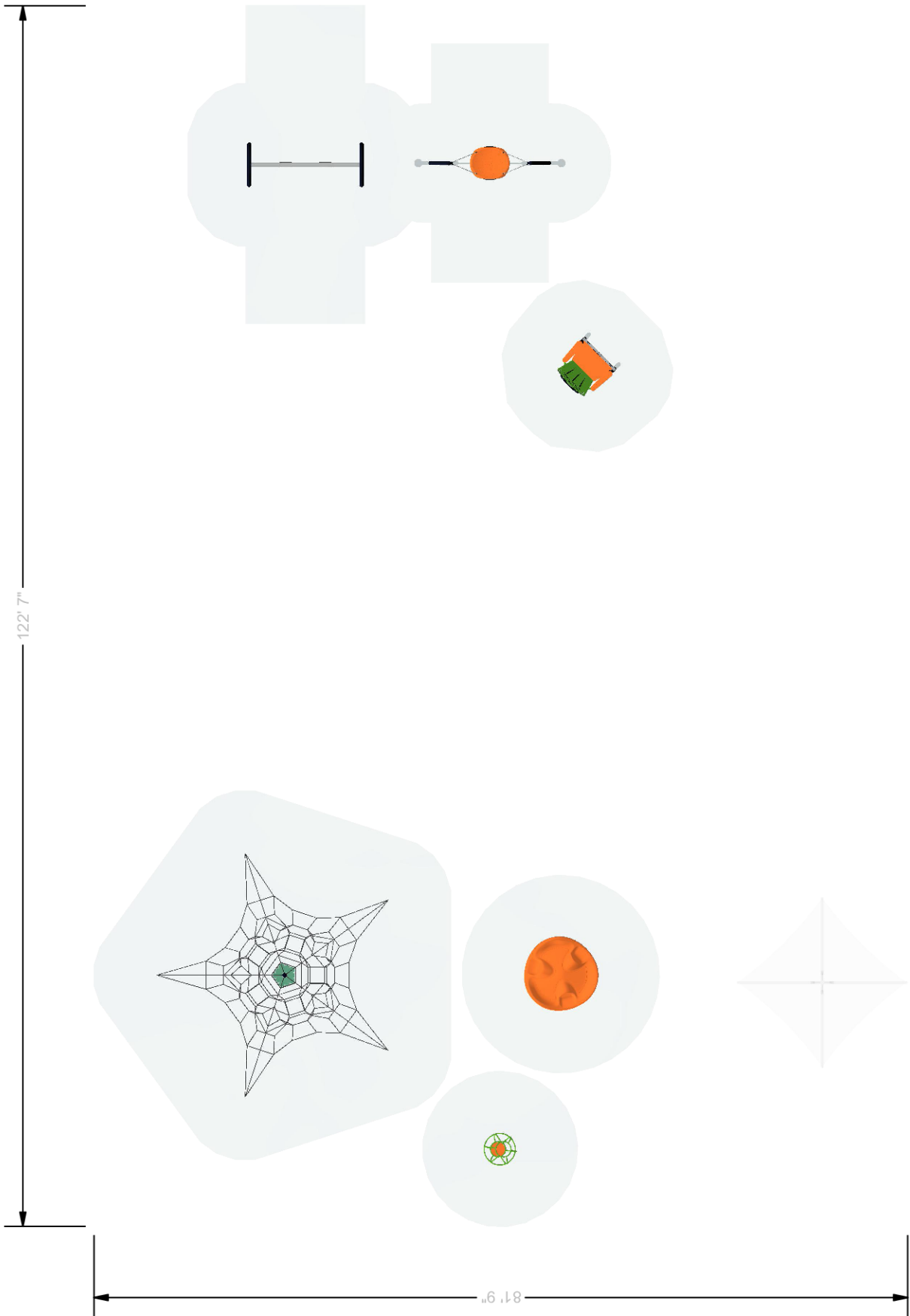
